## **BID # 21-13-5-8 Drums & Accessories**

Invitations were sent to seven (7) vendors. Two (2) of those vendors responded with a bid and two (2) more responded from invitations posted to the Henderson County Schools Website. Although the bids from Washington Music Center for \$10,146.00 and Sam Ash Quikship Corp. for \$9,931.80 were lower than Forks Drum Closet for \$10,519.00, those two companies could not deliver the product until after the date the band needs the drums and accessories. We are recommending that Bid # 21-13-5-8 Drums and Accessories be awarded to Forks Drum Closet.

## **BID # 22-13-5-8 Canned Goods & Frozen Food Items**

One bid was received and publicly opened on August 9, 2013 for Canned Goods & Frozen Food Items. One vendor returned the bid invitation with “No Bid” written on the envelope. A third vendor did not respond. We are recommending the Henderson County Board of Education award Bid # 22-13-5-8 for Canned Goods & Frozen Food Items to CRS OneSource.
