New Professional Development Training Requirements for School Board Members.

The Kentucky Department of Education is currently drafting new regulations for approval by the Kentucky Board of Education on mandated training for local school board members. The new regulation will address yearly training in school finance, board member ethics and superintendent evaluation. This year's meetings will examine the new requirements in detail and a plan of action for all school board members to comply with the new requirement. In addition we will begin each regional meeting with a presentation from Gov. Beshear's office on the topic of implementation of SB 97, the mandatory school attendance age bill. The governor and First Lady Jane Beshear are encouraging school districts as they develop strategies to educate 16- and 17-year-old students with alternative programs.
