BACKGROUND AND RATIONALE: The renovation of the existing Mary Todd Elementary School is listed as priority 1c.6 on FCPS's 2009 District Facility Plan. Murphy + Graves Architects has produced Construction Documents (plans, specifications, bidding requirements, etc.) describing a renovation of the existing building and the construction of an addition totaling approximately 67,466 SF to serve 550 students, based upon FCPS elementary school program standards. Bids were received on March 3, 2011 and construction began in June, 2011. The Department of Physical Support Services, the design consultants and the local building code officials have reviewed the progress of the work. Changes to the original plans and specifications have been necessary in order to satisfy the requirements described below. Approval of these changes allows the work to be completed.
