The following grants need to be on the January consent agenda.

The Career and Technical Education program, in conjunction with Union and Webster counties and Henderson Community College, seek approval to apply for a federal Youth Career Connect grant in the amount of two million dollars over four years to implement the TRACK program to prepare students for Registered Apprenticeship programs and/or college coursework.

All eight elementary schools seek approval to apply for the state's "Read To Achieve" primary reading intervention program funding in the amount of \$48,500 each year for two years. The purpose is to provide primary students scoring at or below the 25th percentile a more intensive reading intervention with a highly trained teacher.

The CTE Unit is applying for the state's Pre-engineering Pipeline grant for North, South and the High School's Project Lead The Way classes in the amount of \$15,000 for each school. The funds will be used for additional esources for the Gateway to Technology classes in the middle schools and the Pre-Engineering program at the high school.

If AdvanceKY-CS is funded, Henderson County High School agrees to:

- Participate in AdvanceKY-CS, an effort to adapt AdvanceKentucky to dramatically accelerate coding awareness and literacy for the 21st century and assist and growth in Advanced Placement Computer Science classes;
- Identify a qualified APCS teacher(s) to teach the class. In preparation, this teacher agrees to attend an AP Summer Institute in Computer Science;
- Consider adding the new AP CS Principles course as may be released by the College Board and as appropriate identify a teacher to teach this class and attend an APSI in preparation for adding the class;
- Involve Professional Coders (computer programmers) in Mentoring APCS teachers;
- Commit APCS teachers to work with a Network of Coding Professionals to deliver coding experiences for students that engage students, help build school wide awareness of coding literacy for the 21st Century, and help support recruitment of students into APCS/Principles classes:
- Commit to teachers attending a multi-day immersion Coding Academy to engage teachers in highly accessible 21st Century coding applications across the core, especially for other STEM classes, and
- Authorize and submit annual unit-record AP enrollments per the format provided by AdvanceKY-CS, release of AP scores and teacher reports on participation in professional development, and reports as may be required by the funder.

In addition, we understand that, if funded, AdvanceKY-CS agrees to support implementation of the original Elements of Success including:

- APSI registration and travel fees;
- Coding Academy registration and travel fees;

- Teacher mentors for both the AP curriculum and for imbedding coding literacy experiences throughout the school;
- Access to a network of professional coders to help generate awareness of coding applications throughout the core for students and teachers;
- AP Exam fees to students enrolled in APCS/Principles classes;
- Student Incentive of \$100 per qualifying score earned on APCS/Principles exams;
- Teacher incentive of \$100 per qualifying score earned on APCS/Principles exams and bonus of \$1000 for meeting preset growth goals for APCS qualifying scores;
- \$1000 bonus shared between the Administrator of Record and AP Coordinator;
- Stipends for APCS teachers and other teachers participating in the Coding Academy.
