VII.B. Report on Alternative Schools Status and Recommendations

Dr. Dewey Hensley, chief academic officer, presented a report and answered Board member questions concerning strategies to improve performance in the alternative schools as well as recommendations and next steps for the success pathways available to non-traditional students who meet alternative school criteria for assistance. Each Board member had an opportunity to comment and ask questions. The alternative school principals were also present to answer questions.

Mrs. Duncan invited the following alternative school principals to come to the table to join in the discussion:

Mr. Haddaway asked Dr. Hensley for an update on planning and transition for The Phoenix School of Discovery.

Mr. Jones requested that the next report include a more holistic view of the data. Dr. Hensley advised that each Board member will receive a packet that includes a more comprehensive overview of each alternative school.

Chairwoman Porter requested the following information: "Please discuss the mental health supports that are in place in high schools and alternative schools; how do we effectively address improving achievement as we suspend students, and what happens in the alternative school placements; what is the probability of a student being assigned to an alternative school that that percentage will graduate or that that percentage will go to the criminal justice system? As we talk about staffing tonight—requesting information about staffing—I would like the Board to receive information that talks about what the staffing formula looks like for all the alternative schools as it pertains to full-time staff, classified, certified, and retired teachers and administrators. Those are my points, and I don't expect any answers tonight."
