Mr. Tackett,

Good afternoon. I am writing to express my displeasure with our proposed placement in the Football Realignment. This proposal puts our closest district opponent 76 miles away and our farthest district opponent approximately 140 miles away. Given the current budget situation for all schools and districts, this proposed alignment causes us to incur a greater cost to provide our students the opportunity to play football. Our cost of travel will increase substantially and our gate will decrease as fewer fans of district rivals will make the trip to Berea. In terms of ease of travel, our assignment to District 5 makes much more sense than District 2. At least in District 5 we can travel primarily by I-75. Additionally, we have a healthy rivalry with Nicholas County HS and Paris HS as we compete together in the Bluegrass Conference. Please see the information below for specific comparisons.

This feedback must be received on or before the close of business on Monday, May 5. **NOTE: Scheduling Moratorium:** Contracts signed prior to May 12, 2014 for the 2015 playing season and beyond are not to be considered valid. Schools are to hold off scheduling until the final alignment is approved.

Throughout this school year, the Board of Control Team Sports Committee has been conducting discussions and working with staff on finalizing a draft alignment of school for the 2015 through 2018 playing seasons. Commissioner Julian Tackett and the KHSAA Board of Control,

Cooper High School is writing to the KHSAA and the Board of Control in regards to the 2015-2018 KHSAA Football Alignment Draft. Cooper High School requests that the Board of Control look at the 6A playoff pairings rotation and consider this proposal.

Class 6A Playoff Alignment Proposal:

We feel the new Class 6A alignment now allows for true geographic pairings for regional playoff competition more so than in years past. Therefore, we ask the KHSAA and the Board of Control to consider allowing Class 6A to be paired in the playoffs the same way the other 5 classes are paired.

We propose the following Regional alignment.

Region 1= District 1 & 2- Western Kentucky Region (8 teams)

Region 2= District 3 & 4- Louisville Region (10/8 teams with the 2^{5th} place going to N KY)

Region 3= District 5 & 6- Northern Kentucky Region (6/8 teams with the 2 Louisville teams)

Region 4= District 7 & 8- Lexington Region (8 teams)

Semi-final Round= Region 1 vs. Region 2
Region 3 vs. Region 4

If this playoff alignment is followed, it would allow the Semi-Final round to consist of 1 team from each of the 8 team regions in the 4th round.

We feel this makes sense for several reasons. It is very sound geographically. Creating geographically sound regional alignment would allow for strong rivalries to be established, it will help playoff revenue for all schools, and it will relieve travel issues that could potentially impact schools from all 8 districts. The only schools that would be forced to travel outside of their region for the first three rounds of the playoffs would be the two fifth place teams from Louisville. Eight of the ten Louisville Schools will be playing in the Louisville Region, all six of the Northern Kentucky schools would be playing in the Northern Kentucky Region, all eight of the Lexington teams would be playing in the Lexington Region, and all eight of the Western Kentucky Schools would be playing in the Western Kentucky region. The only playoff travel that would be required outside of the region would be for the semifinal round.

The other benefit from following this playoff pairing system would be that the 2 Louisville schools travelling to compete as the #4 seeded teams in northern Kentucky would not have to play a team from their district in the first three rounds of the playoffs. This is a real possibility if the northern Kentucky districts are matched up with the Louisville districts in the first round. A Louisville team could potentially play a district opponent in the first round.

We feel that this would benefit all 4 regions and would save all the schools potential travel issues and be more consistent with the other classes throughout the state which allows for rivalries to be created through the playoffs. This would eliminate the problem with rotating regional changes in Class 6A on a yearly basis. With the current alignment the only class throughout the state that changes pairings in the playoffs is 6A.

This letter is concerning the proposed high school football redistricting for the 2015 season. My school, Henry County High School is scheduled to be aligned in the following new district: Boyle, Garrard, Henry County, Western Hills and Lexington Catholic. This proposed district creates a substantial travel issue for our school system (estimated 251 miles one-bus, one-way from home school to away schools and we always take more than one bus). We would be leaving our current district of Louisville area schools for this 2015 realignment. In terms of mileage, it makes much more sense for us to play in the realigned district that features Bardstown, Thomas Nelson, Central, Moore and Waggener. I do not know how feasible six team districts are in terms of your realignment efforts (there are other proposed six-team districts), but that would be the logical realignment on our end.

If your efforts are to maintain five-team districts, then just by having us switch places with Bardstown, putting them in the aforementioned Boyle, Garrard and Lexington Catholic district (estimated 159 miles one-bus, one-way for Bardstown from home school to away schools), the realignment process makes much more sense in terms of mileage. For Henry County to travel to the three Louisville schools would be approximately 121 miles one-bus, one-way home school to away schools.

Here is a look at an excel representation of those numbers previously mentioned:

While there isn't always a huge disparity in the mileage, the time is noticeable due to routes we would have to take to travel Central Kentucky (whereas Bardstown would basically travel on a straight shot down the Bluegrass Parkway). Henry County, like so many other schools, is under huge budgetary constraints when it comes to athletic travel. I have let my coaches know that they should not request to schedule and hence travel any distances to Lexington and beyond (within 1 hour from school) for a sporting event. We consider games in Jefferson County a logical opportunity due to its close distance. In fact, our football team is a member of the Greater Louisville Football Association (scheduling out freshman and JV teams who play in a Louisville Area League).

I also realize that Bardstown is anticipated to be placed in a district with not only the Louisville schools mentioned, but also fellow Nelson County School, Thomas Nelson. You may be hesitant to switch these districts around and tamper with this natural in-county rivalry within the district. If this is unavoidable, then bring both schools into the proposed "District 4" and move Henry County along with Western Hills into "District 3". The overall time / mileage in a comparison between Thomas Nelson and Western Hills are very similar as you can see below:

Hi Steve,

Right now, there are two schools that have made the request to the Board of Control that schools that withdraw from play are only out 2 years. That seems fair to all involved as it addresses the contract cycle.

If you are sincerely interested in playing up, I would make that request with a letter to me and email it in within the next day or so. Otherwise, I would write a note on letterhead that simply asks for permission to be out only two years if you withdraw. You wouldn't be officially withdrawing at that point, just requesting. That way, if they happen NOT to approve the two year provision (instead of four), then we can come back to you and see what you want to do.

Hope that all makes sense. If not, give me a call at the office.

Mr. Tackett,

With the redistricting of football for 2015, I wanted to see what some of our options at Grant County would be. We are a 5A school, but football is not the main sport here and probably never will be. Also, we are a rural school district. As far as the number of our students who participate in football is concerned, we are more of a 3A or even a 2A school in reality. Last year in our district we were outscored on average of 48-7. We don't anticipate being able to compete any better by having to play traditional football powers such as Highlands and Covington Catholic. I have seen the athletes that our boys have to compete against and they are just usually so much bigger and stronger than our boys, let alone much quicker. As a result we get more injuries (and players quitting) and by the end of the season we are just depleted. Our coaches here do a wonderful job, but they are just able to do so much.

I wanted to see what are options might be. Our coach has wondered if we might even be better off by playing up at 6A with the feeling we can likely compete better against the schools we have been playing against than against Highlands, Covington Catholic, and Dixie. Would it also be possible for us to play for a few years without being eligible to the playoffs while we try to build a football program here that will compete?

Dear BOC Members,

Concerning the proposed new football alignment for the 2015-2018 seasons, this is a request for consideration of the following. In class 5-A, a district be composed of the 6 schools in Jefferson County that will be in the 5-A classification, Atherton, Doss, Fairdale, Fern Creek, Iroquois and Southern. This would certainly make geographical sense, but it will also put schools together that have very similar student populations.

Some background and overall view of the Louisville metro area may help with other school alignments as well. The current 5A alignment for the area has District 3, Grayson Co., Iroquois, Jeffersontown, John Hardin and North Hardin. District 4, Bullitt Central, Bullitt East, North Bullitt and Shelby County. Three teams will potentially be moving out of District 3, Jeffersontown and North Hardin to class 6A and John Hardin to 4A.

A possibility could be that Grayson County be moved into a district with the three Bullitt County Schools. That would be a shorter trip, on the WK Pkwy and I-65, for Grayson Co., than their current alignment, which has them traveling thru Bullitt County, to Iroquois and Jeffersontown. Josh Basham, the A.D. at Grayson Co. was contacted concerning this and said he would support this scenario. Another addition to that district could be Nelson County, which will be playing up to 5A, and they could take the place of Shelby County, which could move into another district, see attached.

Thanks for your consideration and hopefully this would be a viable solution and can help with your difficult task of the realignment process. Attached you will also find a draft of a possible alignment for all of Class 5A, which was developed using the existing alignment as a guide.



Draft 5A Football Alignment

KHSAA COMPETITION RULES

Governing Football

*(Adopted by the Board of Control for all play in this sport)
(Where these rules refer to the Commissioner, they shall refer to the Commissioner of the KHSAA. Sports specific duties may be appropriately delegated to a member of the Commission for the implementation of these rules. See Case Situations for specific rulings and interpretations used to administer these provisions)*

I) Assignment of Schools

A) Alignment of Teams for Postseason Play

The Kentucky High School Athletic Association shall sponsor postseason competition in football, provided that ten (10) percent of the member schools declare intentions to participate in said competition. Member schools not desiring to participate in KHSAA sponsored postseason competition shall notify the Association office prior to July 15, by the Commissioner's office. The alignment for football for the 2011 through 2014 playing seasons shall be as follows —

(&) - Pendleton County has withdrawn from district play for the 2013 and 2014 seasons.

(%) - McCracken County and Thomas Nelson will enter district play for the 2013 and 2014 seasons.

B) Enrollment and Criteria for Determining Classes

- 1) The basis for determining the schools to be placed in Class 1A, 2A, 3A, 4A, 5A and 6A will be the average boys enrollment, including all non-graded special education students, in grades 9-12 for the two most recent years available for the entire membership at the time of classification.
- 2) Initial classification for the 2011-2014 period is based on enrollment data verified by the Kentucky Department of Education for the two years through the enrollment of the 2008-2009 and 2009-2010 school year.
- 3) The enrollment data used to determine the class boundaries shall be obtained from the Kentucky Department of Education or other verifiable sources in the case of non-public schools.
- 4) The classification shall be for a four-year period, which may be extended by the Board of Control. The alignment will be reviewed upon receipt of the 2011-2012 school year enrollment information from the Kentucky Department of Education for possible adjustment to begin with the 2013 playing season.
- 5) The schools shall be placed in enrollment ranked order (by boys four grade enrollments, after adjustment for single-sex schools).
- 6) The minimum number of teams necessary for a full bracket in the playoff system (32 teams) shall be placed in the highest class (6A) and the lowest enrollment class (1A). The remaining schools shall then be placed into approximately equal divisions in classes 2A through 5A.
- 7) The Board shall attempt to ensure that districts do not fall below four (4) teams and that travel distance is the primary determinant in both alignment decisions, and decisions involving playoff pairings.
- 8) The highest and lowest enrollment average from each class shall form the bounds of the class for the purpose of making adjustments after two years or for adding new teams.
- 9) If there are an odd number of schools or the number of schools is not evenly divisible by the number of classes, the extra teams shall be placed from the lowest class first, up to the highest

Madison Southern High School is opposed to the realignment proposed earlier this month due to several factors. With the current teams in 5a, district 7, we have over the years fought bitter contest with these schools and have built up not only a following of fans but have also developed good, strong rivalries. It has been the opinion of many people that 2 of the strongest teams in 5a last year were in district 7 and we hope to continue this rivalry not only this year but in the years to come. We have a strong desire to be back into a district with Pulaski, South Laurel, Lincoln, and Southwestern, and they have a desire for us to keep the up the rivalries developed over the years together. This alignment is good for the district and is good for high school football as well. We understand that this is personal to us but we also understand that the numerous phone calls we have received have been laced with questions about the loss of history, tradition and competitiveness among the current schools. Not only has there been a tradition among the schools in the current district but over the last few years there have been a rivalry between region 7 and region 8 that will be lost, namely the one between Madison Southern and Harlan County. This game will also be lost to the realignment proposed if we are moved out of the 7th district, this is not good for high school football. We understand that the alignment process is not an easy one and doesn't come without its fair share of compromises. The 7th district currently has 6 teams and after realignment has 5, but has included Whitley County. North Laurel has indicated that their move to the 8th district was a non-issue with them but leaves that district with only four teams. If Madison Southern were moved back to the 7th district and Whitley to the 8th, that would leave both with 5 and the 6th district with 4. It is felt that a 4 team district in the 6th district instead of the 8th would benefit those teams most affected in this proposed alignment. Although we base our objections on the proposed alignment on the points mentioned above, there is also a large difference between the amounts of money that will be spent on travel to district games if the alignment is left unchanged. Currently for a bus to travel to the 4 teams we are requesting to join in the new alignment, Pulaski, Southwestern, South Laurel, and Lincoln, the round trip for one bus is around 318 miles. This amount is doubled for two busses. If our district remains unchanged under the new proposal the round trip total for the new district would be around 514 miles, doubled for two busses. With two buses, the difference between districts would be around 408 miles and at the current Madison County rate of 1.75 dollars per mile that is a direct cost of 714 dollars that would not be spent if we stayed in the 7th district. This cost is not bore solely by one school but i still an amount split among schools base on home/away schedule. We only ask for reconsideration of our proposed move to the 6th district based on the arguments stated and that we remain in the 7th district to continue to build and promote high school football that is in the best interest of Kentucky.

Mr. Webb and KHSAA Board of Controllers,

On behalf of Magoffin County Schools, we would like to address our concern with the proposed realignment of districts for the 2015-2018 school years.

Over the past sixteen years, Magoffin County has been moved to a different district seven times (see attachment). The proposed reassignment once again moves our school away from three of our neighboring districts. These many reassignments have had a negative impact on the morale of our students, in part because we are unable to develop healthy sportsmanship rivalries with our neighboring school districts. This does little to motivate our teams to be more competitive.

Being moved from district to district so many times over recent years has caused our district to view itself somewhat as a “foster child” school moved from place to place when some other district needs “yet another team” to fill its roster; our team feels it has no true home.

If the 2015-2018 reassignment moves forward as planned, we will give strong and careful consideration to leaving district affiliation to become an independent team. While we do not desire to take such action, we feel we may be left with no reasonable alternative.

We would implore you to give very careful consideration to the implications of this move before making any decision to reassign our district yet again. Thank you for your consideration in this matter.

6. Of the 3 possible solutions option C seems the simplest and the most financially sound.

Commissioner Julian Tackett and the KHSAA Board of Control,

Simon Kenton High School is writing to the KHSAA and the Board of Control in regards to the 2015-2018 KHSAA Football Alignment Draft. Simon Kenton High School requests that the Board of Control look at the 6A playoff pairings rotation and consider this proposal.

Class 6A Playoff Alignment Proposal:

We feel the new Class 6A alignment now allows for true geographic pairings for regional playoff competition more so than in years past. Therefore, we ask the KHSAA and the Board of Control to consider allowing Class 6A to be paired in the playoffs the same way the other 5 classes are paired. We propose the following Regional alignment.

Region 1= District 1 & 2- Western Kentucky Region (8 teams)

Region 2= District 3 & 4- Louisville Region (10/8 teams with the 2 5th place going to N KY)

Region 3= District 5 & 6- Northern Kentucky Region (6/8 teams with the 2 Louisville teams)

Region 4= District 7 & 8- Lexington Region (8 teams)

Semi-final Round= Region 1 vs. Region 2

Region 3 vs. Region 4

If this playoff alignment is followed, it would allow the Semi-Final round to consist of 1 team from each of the 8 team regions in the 4th round.

We feel this makes sense for several reasons. It is very sound geographically. Creating geographically sound regional alignment would allow for strong rivalries to be established, it will help playoff revenue for all schools, and it will relieve travel issues that could potentially impact schools from all 8 districts. The only schools that would be forced to travel outside of their region for the first three rounds of the playoffs would be the two fifth place teams from Louisville. Eight of the ten Louisville Schools will be playing in the Louisville Region, all six of the Northern Kentucky schools would be playing in the Northern Kentucky Region, all eight of the Lexington teams would be playing in the Lexington Region, and all eight of the Western Kentucky Schools would be playing in the Western Kentucky region. The only playoff travel that would be required outside of the region would be for the semifinal round.

The other benefit from following this playoff pairing system would be that the 2 Louisville schools travelling to compete as the #4 seeded teams in northern Kentucky would not have to play a team from their district in the first three rounds of the playoffs. This is a real possibility if the northern Kentucky districts are matched up with the Louisville districts in the first round. A Louisville team could potentially play a district opponent in the first round.

We feel that this would benefit all 4 regions and would save all the schools potential travel issues and be more consistent with the other classes throughout the state which allows for rivalries to be created through the playoffs. This would eliminate the problem with rotating regional changes in Class 6A on a yearly basis. With the current alignment the only class throughout the state that changes pairings in the playoffs is 6A.
