2015-2018 FOOTBALL REALIGNMENT PROJECT
FINAL INITIAL RECOMMENDATIONS

ENROLLMENT APPEAL

- Consider Sheldon Clark request, but ensure that they are aware of the mid-course adjustment procedure after the 2016 season if request not approved

PLAYING UP/DOWN

- Approve Bath County and West Carter, place both in District 5 of Class 3A
- Approve Shelby County request to return to original class (4A), and align in District 4
- Deny Shawnee request to play in a lower class than enrollment dictates
- Deny North Hardin request, but ensure that they are aware of the mid-course adjustment procedure after the 2016 season

GEOGRAPHIC MOVES

1A

- Approve Berea assignment to District 5. In either case, they will be part of a 5 team district.
- Consider request by both Pikeville and Phelps to move Hazard to District 7 and let that be the 6 team district whose 5th place team pairs with District 6 (No response from Hazard to the draft)

2A

- Consider Webster County request to switch with Todd County (Todd favored position in draft alignment)

3A

- Approve Henry County request to move to District 3 in 3A (geography)
- Consider movement of Magoffin into District 7, but be aware of Powell's request to not have anyone else inserted into district
- Consider Jackson County request into District 7, but be aware of Powell's request to not have anyone else inserted into district

4A

- Consider Franklin County alternative districts for 3-4-5
 - District 3--Breckinridge Co., John Hardin, Marion Co. and Taylor Co.
 - District 4--Collins, North Oldham, Spencer Co., Western and Valley
 - District 5--Franklin Co., East Jessamine, West Jessamine and Mercer Co.

5A

- Decline Madison Southern request to move to District 7 due to Shelby move
- Approve Whitley County move to District 8
- Consider Bullitt Central request to switch Fairdale and Southern with North Oldham and South Oldham in Districts 3 and 4

POSTSEASON

- Consider Request from Multiple Schools for rotating pairings

ALIGNMENT ISSUES

- If withdraw, out through 2016 or 2018. Recommend 2018.
- Mid-Course Adjustments
 - Schools would be considered for move if they have are within the boundaries of another class, and have had at least a 10% change in four year average enrollment during the two-year period.
 - Adjustment will happen when the enrollment figures are received for 2015-2016, and will be based on the four-year average enrollments of 2015-2016, 2014-2015, 2013-2014 and 2012-2013
