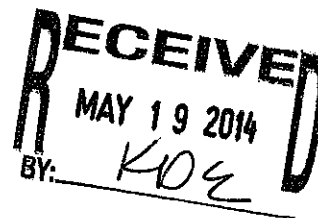

Re: Scott Co. School District 4 residents' petition for change in boundary lines of divisions per KRS160.210 (3) (4a,b,c)

To Kentucky Board of Education:

Enclosed is a Scott Co. school Board Of Education District 4 residents' petition requesting a change in Scott Co. KY school board members' boundary divisions for the following reasons:
school district divisions are not divided as nearly equal in population as can be reasonably expected.
Current divisions: Dist. 1-12,706, Dist. 2-11,742, Dist. 3-11,114, Dist. 4-6,931, Dist. 5-4,671 as listed in 2010 census researched by County Clerk & Planning & Zoning.
County Clerk Johnson stated 2014 redistricting of magisterial, Congressional & voting precincts has caused 17 split-vote conflicts, causing school districts to vote in 2 different locations in 17 areas.
Dist. 4 school Board Member Rebecca Sams stated at meeting that there have been no changes to boundaries in her 24 years on the Board.

The Superintendent & Board members requested County Clerk R. Johnson to advise the Board on redistricting. Her plan equalizes population better: Dist 1-9,422, Dist. 2-9,188, Dist 3-9,676, Dist 4-9,710, Dist. 5-9,148; it also eliminates 17 split-vote divisions, retains all members in their districts & current school areas. Four (4) Board members expressed approval at a work session but further redistricting discussion was delayed until sometime after May 30, 2014 with no date designated.

To ensure that in November 2014 residents will have one voting district, will know their district lines for possible candidacy filing for their Board district, and school district divisions are as equal in population as can be expected, residents believe this needs to be completed by early July. Therefore, we submit this petition to the Kentucky Board of Education.
