In May, 2014, an evaluation was done by the 2013-2014 Board members and results were shared and discussed with the Commissioner immediately prior to the meeting. The Board expressed extremely high satisfaction with the Commissioner as evidenced by an evaluation of 3 (good) or 4 (excellent) on 586 of 592 indicators on the Board evaluation (99%), including 469 of those marked excellent.

### **Report from the Officials Policy Committee**

#### **Consider Officials Pay Schedule Including Discussion of Policy Clarification on Mid-Course Requests to Regional Policy Boards**

Annually, the Board considers a group of sports for adjustment to the statewide standard fee for varsity play. The sports scheduled for review were Volleyball, Track/Cross Country and Swimming. These sports are paid similarly to most neighboring states, or in some cases, a better standard

rate. It was noted that staff was sensitive to the fact that volleyball was recently raised to best 3 of 5 in most areas of the state. Based on the review, staff recommended no changes to fees in these sports.

Staff also reviewed the situation with local associations and assigners coming to policy boards on a sometimes annual basis for raises to sports when the state fee is not being considered at the varsity level.

Staff recommends the following language to be added to the fee schedule:

“Requests for changes in the varsity travel allowance, as well as requests for changes in the non-varsity fee (freshmen and JV) from local associations and assigning secretaries may only be presented in the year following standard review by the Board of Control in a specific sport. In all other cases, such requests are to be considered not germane at that time.”

### **Report from the Audit/Finance Committee**

Audit and Finance Chair Henry Webb made a report of the items that were reviewed and discussed by the committee during their meeting.

It was reiterated from the discussion at the April Meeting that some budget reductions would be necessary based on the current year's finances, including:

1. A reduction in the field visits for Title IX revisits per year and an extension in the amount of time it would take to complete this revisit cycle.
2. Elimination of the KHSAA paying for regional trophies and medals in individual sports and sport activities with the transfer of that cost to the post season tournament treasuries (not to include golf, tennis, or bass fishing which have minimal if any opportunities to charge admission).

In addition, approval was recommended for the following items:

1. Approve the recommendations regarding the evaluation of the Commissioner;
2. Approve the following personnel recommendations following review and discussion by the Committee for 2014-2015:
  - a. Following evaluation, review the additional compensation given to any individual designated as Legal Assistant/Records Custodian, and make appropriate, evaluation-based adjustments;
  - b. Following evaluation, review the additional compensation given to any individual designated as Board of Control Secretary and Office Manager, and make appropriate, evaluation-based adjustments;

- c. Increase the flat salary paid to the physical plant director from \$24,400 to \$25,100 for 2014-2015;
  - d. Increment the salary schedule for all other cells in the employee salary schedule, along with the contracted legal counsel, by 1.0% effective July 1, 2014 and a minimum of 2.0% effective July 1, 2015.
  - e. The two paid internship positions will be consolidated into one position, with that person paid on the lowest level salary line to comply with wage and hour restrictions; a savings of approximately \$21,000.
  - f. Until further review by the Board of Control, the vacant full-time position of Administrative Support Specialist will remain available and open through the 2014-2015 budget development process.
  - g. Authorize extension of the contract for the General Counsel to a full four-year term contingent upon satisfactory evaluation by the Commissioner;
3. Approve the necessary transfer of funds into and out of the designated accounts for known transactions from the 2012-2013 and 2013-2014 fiscal years to close the fiscal year, including the transfer of funds for designated sick leave and other calculated amounts. Approve the remainder of the Designate Fund Categories and calculations as established in the past audits.
  4. Approve budget status report for 2013-2014.
  5. Authorize Commissioner to purchase car per corporate contract and assign to staff, dispose of old fully depreciated vehicle.
  6. Accept the 2012-2013 Audit Presentation by Hicks and Associates
  7. Following review of the iHigh Fund Raising contract, recognizing that the contract with iHigh.com expires June 30, empower the Commissioner to meet with iHigh and enter into final negotiations, and to sign a new one-year contract for the 2014-2015 year which will not be considered to be an extension of the existing agreement.
