BID RECOMMENDATIONS:

T-SHIRTS, SWEATSHIRTS/PANTS, AND POLOS Bid # 15-14-5-11

We received 24 bids for T-Shirts, Sweatshirts/Pants, and Polos. We are recommending that all vendors highlighted on the bid tabulation sheet be awarded the contract so that individual schools and interest groups can make the best selection based on their particular needs and prices available. This is allowed under the model procurement laws.

FUEL BID # 16-14-5-11

Bids were received from Home Oil & Gas Company, Heritage Petroleum, LLC, and Petroleum Traders for gasoline and diesel fuel. Of the 3 bidders Home Oil and Gas and Heritage Petroleum, LLC were very close in their prices. With the Rack Price fluctuating with the price of oil on the open market, the differential cost along with tax rates were used in deciding the low bidder. On diesel fuel "low sulfur," Home Oil & Gas had the lowest differential cost, but was higher in their tax rates. When the differential cost and tax rates were added together, Home Oil and Gas was \$.04 lower than Heritage Petroleum, LLC. On unleaded 87 octane, Home Oil & Gas was the only bidder. On E10 gasoline with 87 octane, Home Oil & Gas was \$.02 cheaper for the total of differential cost and taxes. Home Oil & Gas Company is located here in Henderson. For these reasons we are recommending that the contract for fuel be awarded to Home Oil & Gas.

BID RENEWAL RECOMMENDATIONS:

OFFICE/BOOKSTORE SUPPLIES BID # 28-13-5-11

All vendors currently awarded the bid for office/bookstore supplies were notified that the current contract would expire on November 30, 2014. We are satisfied with both the service and products from these companies and are recommending that the contract be renewed for an additional year.

TEACHING SUPPLIES BID # 20-12-5-11

This bid was first renewed in November 2013 with all vendors awarded the original bid. Schools are satisfied with the service from each vendor for a variety of teaching supplies. We are recommending that this contract be renewed again for a one year period.

SCIENCE SUPPLIES BID # 21-12-5-11

This contract was also renewed in November 2013. Again the schools are satisfied with the service from these multiple vendors. We are recommending this contract be renewed for a second one year period.

BUILDING SUPPLIES & MATERIALS BID # 22-12-5-11

Lowes Home Improvement, Complete Lumber, and Norris Ace Home Center currently have the contract for building supplies & materials which is due to expire on November 30, 2014. All three companies were sent a request to renew their contract and have all responded that they are willing to renew for a one year extension of that contract. We are recommending the Board take this action.

WORKMAN'S COMPENSATION INSURANCE BID # 25-13-5-12

E.M. Ford was awarded the bid for Worker's Compensation in 2011, and has been awarded the contract each subsequent year. Since 2009, the District's workman's compensation coverage has been placed with KEMI. This year, the District received a dividend check from KEMI for \$11,526. Additionally, we received a renewal quote from Mike Hazelwood showing we would receive a \$30, 854 discount if we renew the contract with KEMI for 2015. Based on the analysis presented by Walt Spencer during the October 13, 2014 work session, it appears that there is a significant financial benefit to the District to keep the coverage in place, that competition is not feasible, and that it is in the interest of the District to renew coverage for one more year. Based on the fact that E.M. Ford has provided excellent service as the District's agent and the significant discount the District will receive by renewing the contract with KEMI, it is our recommendation that we exercise the option to renew and award the bid for workman's compensation to E.M. Ford.
