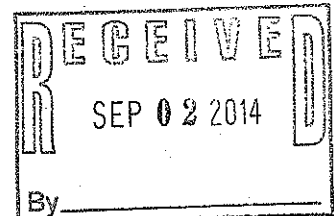

**BRECKINRIDGE COUNTY SCHOOL DISTRICT
LOCAL/STATE BOARD FACILITIES HEARING REPORT**

A Local/State public hearing was held at the Breckinridge County Board of Education Annex on July 30, 2014, at 5:30 p.m. (CDT). The purpose of the public hearing was to propose a new District Facility Plan developed by the Breckinridge County Local Planning Committee. The Local Planning Committee (LPC) voted unanimously (11-0) in favor of the proposed new plan and the Board voted 5-0 to approve the new plan.

There were six (6) individuals in attendance. Grover Canty, Facilitator for the Kentucky School Boards Association, served as the district-appointed hearing officer.

COMMENTS

Mr. Mike Moreland called the public hearing to order and welcomed the hearing officer to the district. The hearing officer outlined the purpose of the hearing and the hearing procedures in accordance with 702 KAR 1:001. It was explained that those persons wishing to speak would be given the opportunity and that written statements would be accepted. All considerations will be made available to the Kentucky Board of Education via the hearing officer's report. The hearing officer read the proposed new District Facility Plan which includes; **Organizational Plan of PS-5, 6-8, 9-12. All School Centers are Permanent except Hardinsburg and Irvington Elementaries which are Transitional. Priority One: No Projects. Priority Two: New construction; Hardinsburg Elementary School and Irvington Elementary School, Renovation/additions to Breckinridge County High School, Breckinridge County Middle School, Ben Johnson Elementary School, Custer Elementary School, Area Tech Center and District White Board Initiative. Priority Three: No Projects. Priority Four: includes construction of a new Central Office, a new Central bus garage facility and renovations to the Annex Building. Priority Five: Construct a baseball field, softball field, lighting for both, concessions/press box, fencing, dugouts and bleacher seating.**

There was no written testimony submitted to the district according to Superintendent Meeks. The floor was opened to those who wished to make a statement. No one spoke on the proposed plan.

RECOMMENDATIONS

It is recommended that the new District Facility Plan developed by the Breckinridge County Local Planning Committee and adopted by the Breckinridge County Board of Education be approved as the District Facility Plan for the Breckinridge County School District. A copy of the new plan is attached.
