### **WORK SESSIONS**

- Mrs. Duncan requested a list of District 5 schools who have earned the Energy Star rating and expressed her concern about the removal of SMART Boards at Maupin Elementary School.
- Ms. Porter congratulated Mrs. Haddad and Mrs. Wesslund on their upcoming November birthdays, requested a report on classified staffing similar to the October 27 *Trends in Staffing* report, and requested the Board receive information before 2015 regarding an equity council mentioned in a report provided to the Council of the Great City Schools outlining the district's efforts to keep students in school. She noted that, of the district's 312 National Board Certified Teachers, only 16 are minority and requested that Administration develop a strategy to increase the number of minority teachers.
- Mr. Haddaway reminded Administration of his October 27 request for information and trend data for National Board Certified Teachers that shows their migration within and without the district.
- Mr. Jones commented on two conferences he attended last week—the Coalition of Essential Schools and a healthcare leadership conference that focused on human performance improvement and modern human relations efforts. "This Board—

probably over the next few years—is going to have to figure out how to broaden our definition of success. We're probably going to have to look at the state metrics and think about what they're missing. Dr. Hargens, it really will fall to you to help make sure that we are broadening our thinking appropriately."
