

**APPROVAL OF A BG-4 FINAL APPROVAL AND PAYMENT**  
**APPLICATION TO THE CONTRACT FOR THE**  
**REPLACEMENT OF THE HENRY CLAY HIGH SCHOOL**  
**GYM BLEACHERS**  
**BG 15-007**

**BACKGROUND AND RATIONALE:** Construction documents were prepared by the architect, Tate Hill Jacobs Architects, for a contract for the replacement of the Henry Clay High School gym bleachers. The BG-1 in the total amount of \$308,912.00 for work by Charron Sports Services and Arrow Electric was approved by the Board in a meeting held on July 14, 2014 and construction began in July, 2014. The Department of Physical Support Services, the design consultants Tate Hill Jacobs Architects, and the local building code officials have reviewed the progress of the work. Minor changes to the original plans and specifications have been necessary in order to: resolve unforeseen existing conflicts found during construction; comply with building code requirements; correct deficiencies in the plans; or to provide improvements over the original specification. The Board has approved 1 change order to Charron Sports Services adding the amount of \$18,560.00 to the total construction cost. The adjusted contract amount is \$327,472.00. All work has been satisfactorily completed by the contractors. At this time, a BG-4 Final Approval and Payment Application Form are presented for acceptance of the work by the Board. **Remaining payments to the contractor shall not be made until all work is completed.**
