Director of Pupil Personnel:

The Barren County Board of Education held its regular meeting, December 16, 2014, and approved a non-resident contract with your district for the 2015-2016 school year.

- The non-resident pupil does not create a situation where cap sizes are exceeded. 1.
- Student does not create a discipline problem. No more than two (2) offenses per semester of Level III, IV as 2. outlined in the student discipline handbook.
- Maintain good attendance. K-12 students to maintain 96% attendance or better. 3.
- Make satisfactory academic progress. Pass ¾ of courses attempted per semester. 4.
- Maintain an attitude of cooperation with the school and participate fully and support all state or district 5. mandated testing programs, classroom activities and assignments.
- That non-resident student is in good standing and has not been suspended or expelled from another district. 6.
- When the number of non-resident students must be limited. Refer to Administrative Procedures 09.12 7. AP.22.

At the discretion of the principal any violation of the agreement may cause the non-resident student to be immediately withdrawn from our school system.
