- Of the 39 Priority Schools that were assessed during the 2013-2014 school year
  - 5 schools scored in the Distinguished category
  - 5 schools scored in the Proficient category
  - 21 schools were categorized as Progressing (met annual measurable objective (AMO), student participation rate for all groups, and graduation rate goal) in addition to their classification as Distinguished, Proficient or Needs Improvement





- 31 of 39 schools had increases in their overall score
- 12 of 39 schools had Overall Scores at or above the state average
- 30 of 39 schools met their Annual Measurable Objective (AMO)
- 22 of 30 high schools achieved their College and Career Ready (CCR) targets
- 28 of 30 high schools showed gains in excess of 20 points in CCR over the last four years
- 2 schools made the Rewards category of High Progress,
  which requires a school to be in the top 10% of

improvement in all schools

College/Career Readiness for All

- Of the 5 Proficient schools, 4 were also identified as Progressing
- Of the 29 schools categorized as Needs Improvement,
  11 were also identified as Progressing
- 7 schools had achievement scores above the state average
- 13 schools had Gap scores above the state average





9 schools had Growth scores above the state average

 21 schools had 10 point or greater increases in their percentile rank than the previous year

 24 of 39 schools had a 5 percentage point or less difference in the combined reading/math score between the Gap group and all students





# **Hub Schools**

- Three Hub Schools Franklin-Simpson, Pulaski County High School, and East Carter High School
- These schools have made extremely high levels of progress; all are rated Distinguished/Progressing (top 10%) in the last state assessment
- Hub schools are
  - Regional models that showcase best or promising practices based on data and results to share with other schools in their region.
  - Recognized for their work in improving student learning and building core processes for sustainability
  - Producing exponentially more students that are college and career ready
  - Hubs of learning activity for teachers, leaders and students

## **Hub Schools**

- Hub Schools were initially intended to provide assistance to Focus Schools, who have greater numbers of students in the achievement gap, but are serving as resources for all schools in the region.
- Hub schools have taken a systems approach to their work, putting systems in place that will assure that the positive changes being implemented are lasting
- During the 2013-14 school 625 people from 89 districts visited.

#### **Additional Results from 2013-2014 Testing**

- While we celebrate the successes of these schools, we continue to have schools that are in need of continued assistance:
  - 8 of 30 high schools failed to meet their CCR targets
  - 9 of 39 schools did not meet their AMO
  - 34 of 39 schools did not meet their Gap targets





#### **Next Steps**

- Implement intentional strategies to reduce Novice
- Continue to collaborate with Priority Schools and Districts in the implementation of PGES
- Continue to implement the LEAD-KY curriculum to strengthen the capacity of leadership in Priority Schools and Districts
- Continue to review data quarterly and develop sustainability plans for exiting schools.
