

AGREEMENT BETWEEN KYTC AND OHIO COUNTY, CONSTRUCT BRIDGE AND APPROACHES ON VARIOUS COUNTY ROADS (SEE BELOW) \$84,000 CB01 RURAL SECONDARY FUND.

AGREEMENT

This Agreement, entered into by and between the Commonwealth of Kentucky, Transportation Cabinet, Department of Rural and Municipal Aid (hereinafter called the Department) and the Ohio County Fiscal Court (hereinafter called the County);

WITNESSETH:

WHEREAS, it would be to the benefit of the traveling public to construct a bridge and approaches on Salem Road (CR 1133)(C00071N) located 2.567 miles south of KY 1544 (MP 2.567) over an unnamed stream AND on Salem Road (CR 1133) located 1.073 miles southwest of KY 505 (MP 3.486) over Muddy Creek AND on Barnetts Creek Road (CR 1374) located 0.267 mile north of KY 1414 (MP 3.273) over Barnett Creek, which shall hereinafter be referred to as the Project; and

WHEREAS, the County has expressed its desire to perform the work for the aforementioned Project and to be responsible for all phases of the Project;

NOW THEREFORE, in consideration of these premises and the mutual covenants contained herein, the parties agree as follows:

1. The Department shall be responsible for providing Rural Secondary funding in an amount not to exceed \$84,000 for the abovementioned Project.
2. If Project is performed by Contract, the County shall employ only contractors prequalified by the Kentucky Transportation Cabinet for the work items included in the Project and shall comply with all legal bidding requirements including, but not limited to, the provisions of KRS 45A and 424. **Concurrence must be obtained by the County through the District 2 Chief District Engineer in Madisonville, KY prior to the awarding of any contract for work or materials to be used on this Project.**
