SBDM Minutes  
January 21, 2014

Principal Jeremy Dodd called the January 21st meeting to order at 4:00 pm in the Dayton High School Library. **Public Comment**

- Cari Cavanaugh said the communication with parents has been better this year than ever.
- Barb Lund brought up recognition of students. There were students called to the office and given certificates and she thought it would be nice to recognize these students in front of the student body. It might get other students to try harder, plus others would know what is happening.

**Student Achievement**

- CCR as of right now, we could pass where we were last year, but we are not where we want to be. We still have time to improve.
- Overall MAP scores were reviewed. Our sophomores showed the most improvement. They had several long term substitutes last year.

**Committee Report**

- **Special Education Department**
  - Angie Buschle reported on the success and failure rates of Special Education Students. The first quarter the failure rate was cut in half from last year. Second quarter the rate went up, but is still in line with regular education students, regular ed. rate is 38% and special ed. is 41%. The biggest jump in failures is 9<sup>th</sup> and 10<sup>th</sup> grade students. The biggest problem for failures seems to be missing assignments.
  - Ms. Buschle asked if there was something we could do to help with the transition from middle school to high school.
  - We need to have a PD for all regular education teachers on making accommodations for special education students. The Sp. Ed. Teachers have given the teachers instruction on making accommodations, but it seems to need to come from higher up. Mr. Dodd e-mailed Ms. Howell, and she thinks this can happen on March 4<sup>th</sup>.
  - How can we get students put into homework help to complete assignments?

**Old Business**

- Mr. Dodd talked about the By-Laws. We need to change the amount of committees. We now have two committees, Leadership and Culture and Climate. This is the first reading of the new By-Law.

**New Business**

- Mr. Dodd told us the current enrollment is up to 365, and we just had 6 more students come in today to enroll.
- The DHS Website is wrong. This needs to be corrected.

Linda Griffith made a motion to extend the meeting. Bonnie Sizemore seconded the motion. The motion carried.

- Mr. Dodd told us the School Improvement Plan is complete
- It was asked what we can do about attendance when the courts won't back us up.
