## APPROVAL OF BID, INTERIM AND PROPOSED CONTRACTS, AND A REVISION TO THE BG-1 PROJECT APPLICATION FOR THE CONSTRUCTION OF THE NEW ELEMENTARY SCHOOL

## NORTH OF I-75/1281 DEER HAVEN LANE (INTERSECTION OF POLO CLUB BOULEVARD & PASSAGE MOUND WAY) BG 14-120

BACKGROUND AND RATIONALE: The construction of a new 650-student elementary school to be located on 15 acres north of I-75 at 1281 Deer Haven Lane is listed as priority 1a.4 on FCPS's 2013 District Facility Plan. Moody-Nolan Architects produced final Construction Documents for bidding describing the construction of a new building totaling approximately 73,000 SF to serve 650 students. The program is consistent with other recent FCPS elementary school projects. The project is planned to start construction around April 1, 2015. Final completion is planned for August 2016. On Wednesday, February 11, 2015, five (5) general contractors submitted proposals on a base bid and eight (8) alternate bids. The results of the bidding are as follows:

PROPOSAL: Based on the review of these proposals, the FCPS staff and the design consultants recommend acceptance of the base bid of \$14,649,000, plus Alternates 1 through 8 for \$331,350. This would bring the value of the proposed total general construction contract with Griggs Enterprises to \$14,980,350. (An existing separate price contract with U.S. Specialties, a KEDC vendor, will not be needed for FCPS to purchase the higher quality plastic laminate casework for this project only as Griggs Enterprises was able to include the preferred items in the apparent low-bid for \$1,895 less than available as a direct purchase by FCPS. This allows acceptance of Alternate 2.) The FCPS staff and the design consultants recommend approval of the proposed contract and revised BG-1. Upon the Board's approval, these documents will be submitted to the KDE District Facilities Branch for review and approval. Approval will allow the award of a contract and construction of the New Elementary School North of I-75 (at the intersection of Polo Club Boulevard and Passage Mound Way) to commence with minimal delay. An interim contract will be required until bond proceeds are available. Based on this recommendation, a revision to the BG-1 is required as follows:
