- personnel. This administrative regulation establishes a statewide professional growth and
- 14 effectiveness system to support and improve the performance of all certified school personnel.
- Section 1. Definitions. (1) "Artifact" means a product of a certified school personnel's work that
- 16 demonstrates knowledge and skills.
- 17 (2) "Assistant principal" means a certified school personnel who devotes the majority of
- 18 employed time in the role of assistant principal, for which administrative certification is required
- by the Education Professional Standards Board pursuant to Title 16 KAR.
- 20 (3) "Certified administrator" means a certified school personnel, other than principal or assistant
- 21 principal, who devotes the majority of employed time in a position for which administrative

- 1 certification is required by the Education Professional Standards Board pursuant to Title 16
- 2 KAR.
- 3 (4) "Certified school personnel" means a certified employee, below the level of superintendent,
- 4 who devotes the majority of employed time in a position in a district for which certification is
- 5 required by the Education Professional Standards Board pursuant to Title 16 KAR and includes
- 6 certified administrators, assistant principals, principals, other professionals, and teachers.
- 7 (5) "Conference" means a meeting between the evaluator and the evaluatee for the purposes of
- 8 providing feedback, analyzing the results of an observation or observations, reviewing other
- 9 evidence to determine the evaluatee's accomplishments and areas for growth, and leading to the
- 10 establishment or revision of a professional growth plan.
- 11 (6) "Evaluatee" means the certified school personnel who is being evaluated.
- 12 (7) "Evaluator" means the primary evaluator as described in KRS 156.557(5)(c)2.
- 13 (8) "Formative evaluation" is defined by KRS 156.557(1)(a).
- 14 (9) "Improvement plan" means a plan for improvement of up to twelve (12) months in duration
- 15 for:
- 16 (a) Teachers **and other professionals** who are rated ineffective in professional practice and have
- a low overall student growth rating; and
- 18 (b) Principals who are rated ineffective in professional practice and have high, expected, or low
- 19 overall student growth rating.
- 20 (10)"Job category" means a group or class of certified school personnel positions with closely
- 21 related functions.

- 1 (11) "Local contribution" means a rating based on the degree to which a teacher, other
- 2 **professional**, principal, or assistant principal meets student growth goals and is used for the
- 3 student growth measure.
- 4 (12) "Local formative growth measures" is defined by KRS 156.557(1)(b).
- 5 (13) "Observation" means a data collection process conducted by a certified observer, in person
- or through video, for the purpose of evaluation, including notes, professional judgments, and
- 7 examination of artifacts made during one (1) or more classroom or worksite visits of any
- 8 duration.
- 9 (14) "Observer certification" means a process of training and ensuring that certified school
- personnel who serve as observers of evaluatees have demonstrated proficiency in rating teachers
- and other professionals for the purposes of evaluation and feedback.
- 12 (15) "Observer <u>calibration</u> [recalibration]" means the process of ensuring that certified school
- personnel have maintained proficiency and accuracy in observing teachers **and other**
- professionals for the purposes of evaluation and providing feedback.
- 15 (16) "Other professionals" means certified school personnel, except for teachers, administrators,
- assistant principals, or principals.
- 17 (17) "Overall student growth rating" means the rating that is calculated for a teacher or other
- 18 professional evaluate pursuant to the requirements of Section 7(9) and (10) of this
- 19 administrative regulation and that is calculated for an assistant principal or principal evaluatee
- pursuant to the requirements of Section 10(8) of this administrative regulation and that is
- 21 <u>calculated for a certified administrator pursuant to the requirements of Section 13 (9) of</u>
- 22 this administrative regulation.

- 1 (18) "Peer observation" means observation and documentation by trained certified school
- 2 personnel **below the level of principal or assistant principal**.
- 3 (19) "Performance criteria" means the areas, skills, or outcomes on which certified school
- 4 personnel are evaluated.
- 5 (20) "Performance rating" means the summative description of a teacher, other professional,
- 6 principal, or assistant principal evaluatee's performance, including the ratings listed in Section
- 7 (8) of this administrative regulation.
- 8 [(21) "Preschool teacher" means a certified school personnel who holds a certificate required by
- 9 16 KAR 2:040 and who meets the preschool lead teacher qualifications required by 704 KAR
- 10 3:410, Section 7.
- 11 (21) [(22)] "Principal" means a certified school personnel who devotes the majority of employed
- time in the role of principal, for which administrative certification is required by the Education
- 13 Professional Standards Board pursuant to 16 KAR 3:050.
- 14 (22) [(23)] "Professional growth and effectiveness system" or "system" means an evaluation
- system to support and improve the performance of certified school personnel that meets the
- requirements of KRS 156.557(1)(c), (2), and (3) and that uses clear and timely feedback to guide
- 17 professional development.
- 18 (23) [(24)] "Professional growth plan" means an individualized plan for a certified personnel that
- is focused on improving professional practice and leadership skills, aligned with performance
- 20 standards and the specific goals and objectives of the school improvement plan or the district
- 21 improvement plan, built using a variety of sources and types of data that reflect student needs
- 22 and strengths, evaluate data, and school and district data, produced in consultation with the
- evaluator as described in Section 9(1), (2), (3), and (4) and Section 12(1), (2), (3), and (4) of this

- administrative regulation, and Section 15(1), (2), (3), and (4) of this administrative
- 2 **regulation** and includes:
- 3 (a) Goals for enrichment and development that are established by the evaluatee in consultation
- 4 with the evaluator;
- 5 (b) Objectives or targets aligned to the goals;
- 6 (c) An action plan for achieving the objectives or targets and a plan for monitoring progress;
- 7 (d) A method for evaluating success; and
- 8 (e) The identification, prioritization, and coordination of presently available school and district
- 9 resources to accomplish the goals.
- 10 (25) "Professional practice" means the demonstration, in the school environment, of the
- evaluatee's professional knowledge and skill.
- 12 (26) "Professional practice rating" means the rating that is calculated for a teacher or other
- professional evaluatee pursuant to Section 7(8) of this administrative regulation and that is
- calculated for a principal or assistant principal evaluatee pursuant to the requirements of Section
- 15 10(7) of this administrative regulation and is calculated for a certified administrator
- evaluatee pursuant to the requirements of Section 13 (6) of this administrative regulation.
- 17 (27) "Self-reflection" means the annual process by which certified school personnel assess the
- 18 effectiveness and adequacy of their knowledge and performance for the purpose of identifying
- 19 areas for professional learning and growth.
- 20 (28) "Sources of evidence" means the multiple measures listed in KRS 156.557(4) and in
- 21 Sections 7 [8] and 10 of this administrative regulation.
- 22 (29) "State contribution" means the student growth percentiles, as defined in 703 KAR 5:200,
- 23 Section 1(11), for teachers and other professionals, and the next generation learners goal for

- principals and assistant principals. or the superintendent's or district's improvement goal
- 2 appropriate for the evaluatee's job category for certified administrators.
- 3 (30) "Student growth" is defined by KRS 156.557(1)(c).
- 4 (31) "Student growth goal" means a goal focused on learning, that is specific, appropriate,
- 5 realistic, and time-bound, that is developed collaboratively and agreed upon by the evaluatee and
- 6 evaluator, and that uses local formative growth measures.
- 7 (32) "Student growth percentile" means each student's rate of change compared to other students
- 8 with a similar test score history.
- 9 (33) "Student voice survey" means the student perception survey provided by the department that
- is administered annually to a minimum of one (1) district-designated group of students per
- teacher or other professional evaluate if the evaluatee directly instructs students throughout
- 12 the school year, or a district designated selection of students and provides data on specific
- aspects of the **instructional environment** [classroom experience] and professional practice of
- the teacher <u>or other professional</u> evaluatee.
- 15 (34) "Summative evaluation" is defined by KRS 156.557(1)(d).
- 16 (35) "Teacher" means a certified school personnel who has been assigned the lead responsibility
- for student learning in a classroom, grade level, subject, or course and holds a teaching certificate
- under <u>Title 16 KAR</u> [<u>16 KAR 2:010 or 16 KAR 2:020</u>].
- 19 (36) "Working conditions survey goal" means a school improvement goal set by a principal or
- assistant principal every two (2) years with the use of data from the department-approved
- 21 working conditions survey.
- Section 2. Implementation Timeline. (1) **Beginning with the 2015-2016** [During the 2014-2015]
- 23 school year, all local districts shall fully implement the requirements of KRS 156.557 and this

1 administrative regulation for all certified school personnel except [other professionals, preschool teachers, and teachers of career and technical education in area technology centers. [If the 2 system plan is approved by the local board of education, a local school district may use the 3 results from the system to inform personnel decisions. The use of a district's present evaluation 4 plan, in addition to the system, during the 2014-2015 school year, shall comply with this 5 administrative regulation. During the 2014-2015 school year, the overall school and district 6 accountability scores described in 703 KAR 5:225 shall not include the results from the system.] 7 (2) Teachers of career and technical education in area technology centers shall fully 8 9 implement the requirements of KRS 156.557 and this administrative regulation beginning with the 2016-2017 school year. - 3 Section 3. Approval of Local Professional Growth and Effectiveness System Plan and
- 4 Procedures. (1) Each local school district shall submit to the department a professional growth
- 5 and effectiveness system plan and procedures to establish the district's evaluation system for all
- 6 certified school personnel.
- 7 (2) The department shall approve each local school district's plan and procedures that comply
- 8 with the requirements established in KRS 156.557 and this administrative regulation.
- 9 Section 4. Local Professional Growth and Effectiveness Policies. The local board of education
- shall establish a written policy for implementing the system for all certified school personnel in
- the district, consistent with the requirements of KRS 156.557 and this administrative regulation.
- 12 The local board of education shall develop, adopt, and submit to the department for approval a
- policy for evaluation of the district superintendent, consistent with the requirements of KRS
- 14 156.557(6) and this administrative regulation.
- 15 Section 5. Local Evaluation Procedures and Forms. (1) A local evaluation committee shall
- develop, and the local board of education shall review and approve, system procedures and forms
- for the evaluation of certified school personnel positions.
- 18 (2) The local board of education shall review and approve procedures and forms that meet the
- requirements of KRS 156.557(5)(c) and include the requirements established in this subsection.
- 20 (a) The district may require the utilization of additional trained administrative personnel to
- 21 observe and provide information to the evaluator.
- 22 (b) The district shall require a minimum of one (1) peer observation of a teacher [5] or other
- professional or certified administrator evaluate during the summative evaluation year

1 documentation of peer observations in the department-approved technology platform for teachers, other professionals and certified administrators, and sharing the documentation 2 with the teacher **or** other professional **and certified administrator** for formative evaluation 3 purposes. Documentation of peer observations may be documented in the department 4 approved technology platform. At the request of a teacher or other professional or certified 5 6 administrator, peer observations may be used in the formative process. (c) Beyond the minimum observation requirements set forth in KRS 156.557 and this 7 administrative regulation, the district may establish uniform requirements for the length, 8 9 frequency, and nature of observations conducted by an evaluator for the purpose of evaluation. (d) The district shall require a teacher or other professional evaluator to conduct a minimum of 10 three (3) observations of a teacher or other professional evaluatee during the summative 11 evaluation cycle, except that the district may reduce the number of minimum observations 12 of a teacher or other professional evaluatee during the summative evaluation cycle for 13 teacher or other professional evaluatees who do not report for work sixty (60) or more 14 consecutive school days. Districts shall include a detailed plan for reduction of minimum 15 observations of teachers or other professional evaluatees who do not report for work sixty 16 17 (60) or more consecutive school days in the district's system plan and procedures submitted to the department for approval pursuant to Section 3 of this administrative regulation. 18 19 shall only require a teacher or other professional evaluator to conduct a minimum of two 20 (2) observations of a teacher or other professional evaluatee during the summative evaluation cycle for teacher or other professional evaluatees hired on or after sixty (60) 21 school days following the first day on which students report to school. [and,] At [at] a 22 23 minimum, one (1) full [classroom] observation shall be conducted during the summative year.

- 1 Observations may be documented [and to document all observations] in the department-
- 2 approved technology platform.
- 3 (e) The district shall require a principal <u>assistant principal and certified administrator</u> evaluator to
- 4 conduct a minimum of two (2) site visits each year.
- 5 (f) The district shall create a process for selection of peer observers.
- 6 (g) The district shall require a formative evaluation conference between the evaluator and the
- 7 evaluatee within five (5) working days following each observation by the evaluator.
- 8 (h) The district shall require the summative evaluation conference be held at the end of the
- 9 summative evaluation cycle and include all applicable system data.
- 10 (i) The district shall require summative evaluation, with multiple observations, to occur annually
- for each teacher or other professional who has not attained continuing service status under KRS
- 12 161.740 or continuing status under KRS 156.800(7) and may utilize the formative data collected
- during the beginning teacher internship period, pursuant to 16 KAR 7:010, in the summative
- evaluation of an intern teacher.
- 15 (j) The district shall require multiple observations of a certified school personnel who has
- attained continuing service status under KRS 161.740 or continuing status under KRS
- 17 156.800(7) and whose observation results are determined to be ineffective.
- 18 (k) The district shall require summative evaluation at least once every three (3) years for a
- teacher or other professional who has attained continuing service status under KRS 161.740 or
- 20 continuing status under KRS 156.800(7).
- 21 (1) The district, upon the request of a teacher or other professional, may use peer observation data
- in the formative process.

- 1 (m) The district shall require summative evaluation annually for a certified administrator,
- 2 assistant principal, or principal. The evaluation criteria and process used to evaluate a
- 3 certified administrator, assistant principal or principal shall be explained to and discussed
- 4 with the evaluatee no later than the end of the evaluatee's first thirty (30) calendar days of
- 5 reporting for employment each school year.
- 6 (n) The district shall require a summative evaluation of a certified school personnel be
- 7 documented in writing and be included in the evaluatee's official personnel record.
- 8 (o) The district shall require documentation of a summative evaluation of a teacher, other
- 9 <u>professional certified administrator</u>, principal, and assistant principal in the department-approved
- 10 technology platform.
- 11 (p) All evidence used to produce a certified school personnel's overall performance rating shall
- be included in the documentation of the summative evaluation.
- 13 (q) The district shall provide an opportunity for a written response by the evaluatee and require
- the response be included in the official personnel record.
- 15 [(3) The local board of education shall develop, adopt, and submit to the department for
- 16 approval procedures for evaluation of the district superintendent, consistent with the
- 17 requirements of KRS 156.557(6) and this administrative regulation.
- 18 Section 6. Training and Testing of Evaluators and Observers. (1) The district shall include
- evaluation and observation training in the district's system plan and procedures submitted to the
- 20 department for approval pursuant to Section 3 of this administrative regulation.
- 21 (2) The district shall ensure an evaluator meets the requirements of the district's system plan and
- procedures prior to evaluating a certified school personnel.
- 23 (3) An evaluator shall be trained, [and] tested and approved on a four (4) year cycle.

- 1 (4) Year one (1) of the district's evaluator training cycle shall include the following training
- 2 requirements:
- 3 (a) Training on KRS 156.557 and the requirements of this administrative regulation;
- 4 (b) Training in identifying effective teaching and management practices, in effective observation
- 5 and conferencing techniques, in development of student growth goals, in providing clear and
- 6 timely feedback, in establishing and assisting with a professional growth plan, and in summative
- 7 decision techniques;
- 8 (c) Training provided by the department for all certified administrator evaluators who have never
- 9 evaluated certified school personnel. Other certified administrators who have not received
- training in the skill areas listed in paragraph (b) of this subsection may also be trained by the
- 11 department; and
- 12 (d) Training, for all other evaluators, by a provider who has been approved by the department as
- a trainer for the Instructional Leadership Improvement Program established in 704 KAR 3:325.
- 14 (5) Year one (1) of the district's evaluator training cycle shall include the testing requirements
- established in this subsection.
- 16 (a) An evaluator shall successfully complete testing of research-based and professionally
- 17 accepted teaching and management practices and effective evaluation techniques.
- 18 (b) The testing shall be conducted by the department or an individual or agency approved by the
- 19 department.
- 20 (c) The testing shall include certification as an observer through the department-approved
- observer certification process for an evaluator who is **evaluating** [observing] teachers or other
- professionals [for the purpose of evaluation].

- 1 (6) The department shall issue year one (1) approval as an evaluator upon the evaluator's
- 2 successful completion of the required evaluation training and testing program and successful
- 3 completion of observer certification.
- 4 (7) Years two (2) and three (3) of the district's evaluator training and testing cycle shall include a
- 5 minimum of six (6) hours in each year and shall include:
- 6 (a) Observer **calibration** [recalibration] training, in the department-approved technology
- 7 platform, for all evaluators who observe teachers or other professionals for the purpose of
- 8 evaluation;
- 9 (b) Update training on professional growth and effectiveness statutes and administrative
- 10 regulations; and
- 11 (c) Training for evaluators on any changes to the Professional Growth and Effectiveness System
- and certified evaluation plan, policies, or procedures.
- 13 (8) Year four (4) of the district's evaluator training and testing cycle shall include refresher
- evaluator training and, if evaluating teachers or other professionals, recertification [refresher
- 15 **observer certification**] training and testing.
- 16 (9) The district shall require peer observers to complete the department-approved [developed]
- peer observer training at least once every three (3) years.
- 18 (10) The district shall designate a contact person responsible for monitoring evaluator training
- and for implementing the system.
- 20 Section 7. Professional Practice Rating and Student Growth Rating for Teachers and Other
- 21 Professionals. (1) The district's professional practice rating form shall utilize The Framework for
- 22 Teaching Evaluation Instrument, 2011 Edition, in conjunction with the Teacher and Other

- 1 Professionals Evaluation Crosswalk, in compliance with KRS 156.557 and the requirements of
- 2 this administrative regulation and shall include the following:
- 3 (a) Planning and Preparation Domain[. Components shall include: Knowledge of Content and
- 4 Pedagogy, Demonstrating Knowledge of Students, Setting Instructional Outcomes,
- 5 Demonstrating Knowledge of Resources, Designing Coherent Instruction, and Designing Student
- 6 Assessments];
- 7 (b) Classroom Environment Domain[. Components shall include: Creating an Environment of
- 8 Respect and Rapport, Establishing a Culture of Learning, Managing Classroom Procedures,
- 9 Managing Student Behavior, and Organizing Physical Space];
- 10 (c) Instruction Domain[. Components shall include: Communicating with Students, Questioning
- 11 and Discussion Techniques, Engaging Students in Learning, Using Assessment in Instruction,
- and Demonstrating Flexibility and Responsiveness]; and
- 13 (d) Professional Responsibilities Domain[. Components shall include: Reflecting on Teaching,
- 14 Maintaining Accurate Records, Communicating with Families, Participating in a Professional
- 15 Community, Growing and Developing Professionally, and Showing Professionalism].
- 16 (2) The district's professional practice rating evaluation form shall list, in each component, the
- performance criteria that characterize effective <u>practice</u> [teaching] and apply to the [teacher]
- 18 evaluatee.
- 19 (3) The district shall explain and discuss the professional practice rating domains, components,
- and performance criteria, and the evaluation process with an [a teacher] evaluatee no later than
- 21 the end of the evaluatee's first thirty (30) calendar days of reporting for employment each school
- 22 year. Amendments to local systems of teacher evaluation approved by the department after the

- end of the <u>evaluatee's</u> [teacher's] first thirty (30) calendar days of the school year shall not apply
- 2 to the evaluatee [teacher] until the following school year.
- 3 (4) A professional practice rating evaluation form shall be specific to the evaluatee [teacher's]
- 4 job category.
- 5 (5) The evaluator shall utilize The Framework for Teaching Evaluation Instrument, 2011 Edition,
- 6 in conjunction with the Teacher and Other Professional Evaluation Crosswalk, in compliance
- 7 with KRS 156.557 and the requirements of this administrative regulation, to determine ratings
- 8 for the <u>evaluatee</u> [teacher] on each of the four (4) domains.
- 9 (6) The evaluator shall use evidence from professional growth plans and self-reflection,
- observation, and student voice surveys, in combination with professional judgment, to inform the
- teacher's or other professional's rating on each of the four (4) domains listed in subsection (1) of
- this section.
- 13 (7) The evaluator may, if included in the district's approved evaluation plan, use additional
- district-determined sources of evidence to inform the teacher's <u>or other professional's</u>
- 15 professional practice rating.
- 16 (8) The evaluator shall utilize the decision rules in this subsection for determining the
- professional practice rating for a teacher <u>or other professional</u>.
- 18 (a) The evaluator shall use the following ratings:
- 19 1. "Exemplary" shall be the rating for performance that consistently exceeds expectations for
- 20 effective performance;
- 21 2. "Accomplished" shall be the rating for performance that consistently meets expectations for
- 22 effective performance;

- 1 3. "Developing" shall be the rating for performance that inconsistently meets expectations for
- 2 effective performance; and
- 4. "Ineffective" shall be the rating for performance that consistently fails to meet expectations for
- 4 effective performance.
- 5 (b) At a minimum, the evaluator shall use the following decision rules in this subsection to
- 6 determine a professional practice rating.
- 7 (c) [(b)] If a teacher or other professional is rated ineffective in the classroom environment
- 8 domain or in the instruction domain, the teacher's <u>or other professional's</u> professional practice
- 9 rating shall be not be exemplary or accomplished.
- 10 (d) [(e)] If a teacher or other professional is rated ineffective in the classroom environment
- domain and in the instruction domain, the teacher's or other professional's professional practice
- rating shall be ineffective.
- 13 (e) [(d)] If a teacher or other professional is rated ineffective in any domain, the teacher's or
- other professional's professional practice rating shall be accomplished, developing, or
- ineffective.
- 16 (f) [(e)] If a teacher or other professional is rated developing in two (2) domains and
- accomplished in two (2) domains, the teacher's <u>or other professional's</u> professional practice
- rating shall be accomplished.
- 19 (g) [f] If a teacher or other professional is rated developing in two (2) domains and exemplary
- in two (2) domains, the teacher's or other professional's professional practice rating shall be
- 21 accomplished.

- 1 (h) [(g)] If a teacher <u>or other professional</u> is rated accomplished in two (2) domains and
- 2 exemplary in two (2) domains, the teacher's <u>or other professional's</u> professional practice rating
- 3 shall be exemplary.
- 4 (9) The district shall determine the teacher's <u>or other professional's</u> overall student growth rating
- 5 as established in this subsection.
- 6 (a) The student growth measure shall consist of a state contribution, when available, and a local
- 7 contribution.
- 8 (b) The Kentucky Board of Education shall determine the scale for low, expected, and high
- 9 growth regarding the state contribution, and the department shall provide the scale to local
- 10 school districts.
- 11 (c) Student growth goals shall be determined as established in this paragraph.
- 1. The teacher <u>or other professional</u> shall develop and implement a minimum of one (1) student
- 13 growth goal each year.
- 2. Because individualized education plan (IEP) goals are student-specific, IEP goals may inform,
- but shall not be used as, student growth goals.
- 16 3. The district shall ensure that student growth goals and measures of student growth are rigorous
- and comparable across schools in the local school district.
- 18 (d) The local school district shall determine the scale for low, expected, and high student growth

- 9 (d) A teacher's <u>or other professional's</u> overall performance category shall be ineffective if:
- 10 1. The professional practice rating is ineffective and the overall student growth rating is
- 11 expected; or
- 2. The professional practice rating is ineffective and the overall student growth rating is low.
- 13 Section 9. Professional Growth Plan and Cycle for Tenured Teachers or Other Professionals. A
- teacher or other professional shall be placed on an appropriate plan and summative evaluation
- 15 cycle based on the professional practice rating and the overall student growth rating, as
- illustrated by the Kentucky Professional Growth Plan and Cycle for Tenured Teachers or Other
- 17 Professionals.
- 18 (1) A teacher or other professional whose professional practice rating is exemplary or
- 19 accomplished and who has an expected or high overall student growth rating shall have a
- 20 professional growth plan that includes: goals set by the teacher or other professional, with
- 21 evaluator input; activities that are evaluatee [teacher]-directed and implemented with colleagues;
- a formative review annually; and a summative evaluation that occurs at the end of year three (3)
- of the evaluation cycle.

- 1 (2) A teacher or other professional whose professional practice rating is accomplished or
- 2 exemplary, with a low overall student growth rating, or developing, with a high overall student
- 3 growth rating, shall have a professional growth plan that includes: goals set by the teacher or
- 4 other professional with evaluator input; if there is a low student growth rating, one (1) goal shall
- 5 focus on low student growth outcome; an annual formative review; and a summative evaluation
- 6 that occurs at the end of year three (3) of the evaluation cycle.
- 7 (3) A teacher <u>or other professional</u> whose professional practice rating is developing, with an
- 8 expected overall student growth rating, shall have a professional growth plan that includes: goals
- 9 set by the teacher <u>or other professional</u> with evaluator input; one (1) goal that addresses
- professional practice or student growth; activities that are evaluatee [teacher]-directed and
- implemented with colleagues; an annual formative review; and a summative evaluation that
- occurs at the end of year three (3) of the evaluation cycle.
- 13 (4) A teacher <u>or other professional</u> whose professional practice rating is developing, with a low
- overall student growth rating, or whose professional practice rating is ineffective, with an
- expected or high overall student growth rating, shall have a professional growth plan that
- includes goals determined by the evaluator: goals shall focus on professional practice and student
- 17 growth, include an annual formative review, and include a summative evaluation that occurs at
- the end of one (1) year.
- 19 (5) A teacher <u>or other professional</u> whose professional practice rating is ineffective, with a low
- 20 overall student growth rating, shall have an improvement plan with goals determined by the
- 21 evaluator: the goals shall focus on low performance areas and a summative evaluation shall
- occur at the end of the plan, whose duration is determined by the evaluator and may last up to
- 23 one (1) year.

- 1 Section 10. Professional Practice Rating and Overall Student Growth Rating for Principals and
- 2 Assistant Principals. (1) The district's professional practice rating form shall utilize the Principal
- 3 and Assistant Principal Performance Standards and the Principal and Assistant Principal
- 4 Performance Standards Crosswalk, in compliance with KRS 156.557 and the requirements of
- 5 this administrative regulation, and shall include the performance standards and descriptors
- 6 established in this subsection.
- 7 (a) Instructional Leadership Performance Standard. The evaluatee fosters the success of all
- 8 students by facilitating the development, communication, implementation, and evaluation of a

- improvement.
- 11 (b) School Climate Performance Standard. The evaluatee fosters the success of all students by
- developing, advocating, and sustaining an academically rigorous, positive, and safe school
- 13 climate.
- 14 (c) Human Resources Management Performance Standard. The evaluatee fosters effective
- 15 human resources management by assisting with selection and induction and by supporting,
- evaluating, and retaining quality instructional and support personnel.
- 17 (d) Organizational Management Performance Standard. The evaluatee fosters the success of all
- students by supporting, managing, and overseeing the school's organization, operation, and use
- 19 of resources.
- 20 (e) Communication and Community Relations Performance Standard. The evaluatee fosters the
- 21 success of all students by communicating and collaborating effectively with stakeholders.

- 1 (f) Professionalism Performance Standard. The evaluatee fosters the success of all students by
- 2 demonstrating professional standards and ethics, engaging in continuous professional learning,
- 3 and contributing to the profession.
- 4 (2) The district's professional practice rating evaluation form for assistant principals and
- 5 principals shall list, in each standard, the performance criteria that characterize professional
- 6 effectiveness and apply to the evaluatee.

- as established in this subsection.
- 16 (a) The student growth measure for principals and assistant principals shall consist of a state
- 17 contribution and a local contribution.
- 18 (b) The state contribution for principals and assistant principals shall be based on the degree to
- which the evaluatee meets the next generation learners goal. A principal's next generation
- learners goal shall be the assistant principal's next generation learners goal as well. **For schools**

- 15 (h) (i) The district shall develop a process for using professional judgment and evidence from the

- 5 (a) An evaluatee's overall performance category shall be exemplary if:
- 6 1. The professional practice rating is exemplary and the overall student growth rating is high;
- 7 2. The professional practice rating is exemplary and the overall student growth rating is
- 8 expected; or
- 9 3. The professional practice rating is accomplished and the overall student growth rating is high.
- 10 (b) An evaluatee's overall performance category shall be accomplished if:
- 1. The professional practice rating is accomplished and the overall student growth rating is

- 19 [Evaluation of Other Professionals and Preschool Teachers During the 2014-2015 School Year.

- 11 district shall include, in the professional growth and effectiveness plan, a plan for the evaluation
- 12 of certified administrators.

- (1) Provide a brief summary of:
- (a) What this administrative regulation does: This administrative regulation establishes a statewide professional growth and effectiveness system, as required by KRS 156.557, for the evaluation, support and improvement of performance of all certified school personnel in school districts.
- (b) The necessity of this administrative regulation: KRS 156.557 requires the agency to develop a framework for a statewide personnel evaluation system for all certified school personnel in school districts and to establish a statewide professional growth and effectiveness system for the evaluation, support and improvement of performance of all certified school personnel in school districts. This administrative regulation includes a framework for a statewide personnel evaluation system and establishes a uniform method of evaluation of certified school personnel in school districts.
- (c) How this administrative regulation conforms to the content of the authorizing statute: As required by KRS 156.557, this administrative regulation establishes a framework for a statewide personnel evaluation system, including a uniform method of evaluation, support and improvement for certified school personnel.
- (d) How this administrative regulation currently assists or will assist in the effective administration of the statutes: This administrative regulation sets out the requirements for the uniform evaluation of certified school personnel, below the level of superintendent as required by KRS 156.557.
- (2) If this is an amendment to an existing administrative regulation, provide a brief summary of:
 (a) How the amendment will change this existing administrative regulation: This amendment to the regulation does the following: Updates implementation timelines for various evaluatee groups. Preschool teachers are no longer a pilot group and will be evaluated as all other certified teachers under the proposed amendment. Other professionals will also end their pilot period and be evaluated pursuant to the system established for certified teachers.

A system of evaluation of certified administrators at the district level is added to the regulation. The proposed amendment incorporates teachers of career and technical education in area technology centers.

The proposed amendment requires that school districts begin using results from the PGES system to inform personnel decisions for teachers, principals and assistant principals beginning in the 2015-2016 school year. Districts must use results from the PGES system to inform personnel decisions for other professionals, certified administrators, and teachers of career and technical education in area technology centers beginning in the 2016-2017 school year.

This amendment makes a change to a decision rule for a teacher's overall rating. The United States Department of Education (USED) requires this change as a contingency of approval of Kentucky's ESEA. Finally, the amendment makes entry of data into the state-approved technology platform optional for all evaluation components except the summative rating.

- (b) The necessity of the amendment to this administrative regulation: The amendments are necessary in order to comply with KRS 156.557, meet the requirements of the USED ESEA waiver and address concerns from the field.
- (c) How the amendment conforms to the content of the authorizing statute: The authorizing statute requires a statewide professional growth and effectiveness system for all certified personnel. The proposed amendment ends system pilots and requires evaluation of additional evaluatee groups. The amendment provides for evaluation of all certified school personnel below the level of superintendent as required by KRS 156.557.
- (d) How the amendment will assist in the effective administration of the statutes: The regulation and amendments provide the framework for evaluation of all certified school personnel as required by KRS 156.557.
- (3) List the type and number of individuals, businesses, organizations, or state and local governments affected by this administrative regulation: All public school districts in Kentucky and all certified school personnel.
- (4) Provide an analysis of how the entities identified in question (3) will be impacted by either the implementation of this administrative regulation, if new, or by the change, if it is an amendment, including: The districts will revise their certified evaluation plan and submit to the Department of Education for approval. Districts will need to apply the guidelines of the regulation to all certified personnel and not just teachers, principals and assistant principals.
- (a) List the actions that each of the regulated entities identified in question (3) will have to take to comply with this administrative regulation or amendment: School districts shall revise their certified evaluation plans to include newly incorporated evaluatees and comply with the proposed amended regulation. School districts shall provide training and resources to school and district personnel to ensure consistent and accurate implementation of the requirements of the statewide evaluation system for certified school personnel.
- (b) In complying with this administrative regulation or amendment, how much will it cost each of the entities identified in question (3): No additional costs to current operations.
- (c) As a result of compliance, what benefits will accrue to the entities identified in question (3): Evaluation of certified school personnel will lead to the support and improvement of the performance of all certified school personnel and promote the continuous professional growth and development of skills needed to be a highly effective certified school personnel as intended by KRS 156.557.

- (a) Initially: Any funds currently being spent in the local school district on teacher evaluation shall be redirected to address the requirements of KRS 156.557 and this administrative regulation. - (b) On a continuing basis: Any funds currently being spent in the local school district on teacher evaluation shall be redirected to address the requirements of KRS 156.557 and this administrative regulation. Local school districts should review how they use currently available state and federal grant funds (e.g. school improvement, Title I, Title II, Professional Development) for possible redirection to implementation of KRS 156.557 and this administrative regulation.
