SUBJECT: APPROVAL OF THE NORTHPARK ELEMENTARY SCHOOL PTA SPRING FLING

FACTS:

North Park Parent Teacher Association Team (PTA) is seeking permission from the Board to host a school wide fundraiser during the 2014-2015 school year. The proposed fundraiser will be used by the PTA for the following reasons:

- a. Purchase of playground equipment to help maintain a safe play area for the students of North Park Elementary School.
- b. Support instructional field trips by paying transportation costs for students to ride buses.

All students will be invited to participate in this fundraiser held at the school. Participation will be voluntary and there will be no penalty for not participating. All students in the school will benefit from the funds raised. It is estimated at \$3,000. Students will not be offered an incentive for participating.

Per new Redbook policies enacted on July 1, 2013, parent organizations are now considered booster clubs that must follow the booster club regulations of the Redbook. One regulation is the approval of school wide fundraisers by the Board of Education. Attached to this decision paper is an F-SA-2A form required by the Redbook. The planned Spring Fling/Carnival is planned for May 9, 2015.

RECOMMENDATION
