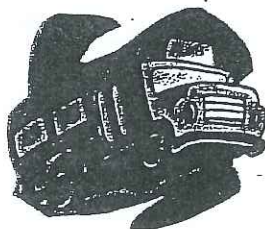
Short Notice Requests Approval Form
