### **KTIP Train-the-Trainer Session**

A new Kentucky Teacher Internship Program (KTIP) train-the-trainers session is scheduled for May 20, 2015, at the EPSB. This training is only for those who will conduct the official beginning teacher committee member trainings for the new KTIP/PGES alignment. Those who have already completed the online TeachScape PGES training will not be required to attend the face-to-face training. However, there will be a short online component to be completed that encompasses the regulatory facets of KTIP.
