




Photo 3: New ductwork and LED lighting have been installed in the auxiliary gymnasium.




Photo 5: HVAC rough-in and ceiling grid installation is ongoing at the Freshmen Wing – First Floor.

Review of previous minutes

Previous meeting minutes were reviewed. There were no comments.

Schedule

Work completed to date

- Morel Construction provided a written "Past Two Weeks Progress" report dated May 28, 2015 (copy attached to these minutes).
- 2. GBMC provided a written "Last Two Weeks" progress update dated May 28, 2015 (copy attached to these minutes).

Anticipated work

- Morel provided their "Next Two Weeks Progress" report dated May 28, 2015 (copy attached to these minutes).
- 2. GBMC provided their "Next Two Weeks" progress update dated May 28, 2015 (copy attached to these minutes).

Delivery dates

- 1. Morel expressed concern about the Trojan logo for the scoreboards. Graphics sent by NHHS are not acceptable to the manufacturer. All parties are to work together to resolve the problem.
- 2. Bleachers are scheduled to arrive June 22.
- 3. Locker delivery schedule is of major concern.
- 4. Ceramic tile should arrive in 5-6 weeks.

Shop drawings

- 1. SCB needs vinyl color samples for the visual display boards.
- 2. SCB requested a meeting with the school principal re: signage. SCB will propose possible dates.
- 3. Kitchen Hood shop drawing review is being held pending re-design of the cafeteria.
- 4. Morel asked if new front doors should be installed this summer. The Owner stated that it's not necessary; that it will be acceptable for new doors to be installed next summer.

Change orders/ASIs/RFIs

Change Order #1 has been approved by the Owner, and copies provided to Morel for signing.

Pay requests

Draft of Payment Application #3 is being reviewed by SCB and the Owner.

Record drawings

All present were asked to be mindful that all conditions that vary from the design documents and the documented existing conditions are to be fully documented on "as-built" drawings throughout this project. Jerry Johnson will be responsible for maintaining as-built documents. SCB, STW, and the Owner will conduct regular reviews of the as-built documents.

Daily clean-up

Good at this time.

Safety issues

Morel has seen some improvement in students' use of the band room doors and students crossing through the construction site, as well as their use of the track.

New business

- 1. Owner's comments:
 - Gary Milby advised that the new easement will require an appraisal. KDE is asking who will pay
 for the new line work. That work is currently in the construction contract.
 - b. Mr. Milby asked when the kitchen/cafeteria package will be bid. He needs financial information for the revised BG form. SCB has just received approval from the district food service director. Shrout Tate Wilson (STW) needs to revise the MEP layout.
 - c. David Wyatt asked about the power to the irrigation systems. Morel and AES indicated that a temporary power feed will be provided.
 - d. Lonnie Dennis asked about the status of the visitor bleachers. Mr. Milby asked for a report from SCB.
 - e. Mr. Milby indicated he will be out of the office for a number of days in June.
 - f. Mr. Dennis asked if unused conduit in the large gymnasium will be removed. Morel responded that it will.
- 2. Architect's comments: None at this time.
- 3. Consultants' comments:
 - a. David Epperson, of STW, advised he will be meeting with Nolin RECC this afternoon to discuss the power feed to the athletic fields. Nolin has an alternative to review with STW.
 - b. GBMC asked if the Owner wants paper or electronic O&M manuals. The Owner asked for paper.

- c. GBMC voiced concern about all the work across the old locker room ceilings. Needs to discuss the options with all affected contractors.
- 4. Contractor's/Subcontractor's comments:
 - a. As soon as possible, Rick Clauson will submit for SCB review a color sample of the "Black" finish for the toilet partition doors.
 - b. Rick indicated that the building inspector mentioned exit clearance width of new gym bleachers.
 - c. Morel needs to verify accent colors of VET in flooring patterns.
 - d. Rick indicated that the computer lab casework is on hold for redesign. SCB will follow up with the school principal about the new layout.
 - e. Steel supplier is holding the arched beams until the radius is verified. SCB will confirm with Jerry Johnson following this meeting.
 - f. Morel needs the epoxy color for the fieldhouse. SCB is awaiting color samples.
 - g. Morel needs the color for the gym ceiling. SCB will verify.
 - h. Morel wants to schedule work on the southeast parking lot, which could interfere with ball practice. Morel will discuss the matter with the school principal.
 - i. Morel asked that all parties review the old locker room ceiling demolition. The Owner wants to provide privacy between the men's and women's areas if the ceiling is completely removed.
 - AES indicated they need to confirm the color of devices and cover plates. STW will review and advise.
 - k. Swift Roofing is concerned about the condition of the metal deck in the small gymnasium, and will need direction as the roof is removed.
 - I. Swift hopes to start the small gym on June 1, weather permitting.

Next scheduled meeting

The next progress meeting will be on Thursday, June 11, at 10:30 a.m. at the job site construction trailer.
