PURPOSE OF MEETING

Kyna Koch introduced Daneen Zimmerman and Lonnie Harp from KASC (Kentucky Association of School Councils. They shared a PowerPoint presentation detailing how allocations are distributed to school councils. A hard copy of the presentation is included in the permanent minutes.

Director of Pupil Personnel

Section 504 Coordinator- (New)

This position will move this to a single position and this employee will report to the Compliance Officer. This will no longer be under Special Education.

A motion was made by Melissa Bacon and seconded by Daryl Love to approve the job description of Section 504 Coordinator. The motion carried with a vote of 4 to 0.

Exceptional Child Nurse (New)

This position will allow the district to receive Medicaid dollars and those funds will more than pay for the position.

A motion was made by Melissa Bacon and seconded by Doug Barnett to approve the job description of Exceptional Child Nurse. The motion carried with a vote of 4 to 0.

Director of Human Resources: Is now a classified position.

Daryl Love wants someone who has an HR background in this role. Melissa Bacon and John Price agreed.

Doug Barnett wants someone with an education background.

A motion was made by Melissa Bacon and seconded by Daryl Love to approve the suggested changes to the Director of Human Resources job description with the following changes: 5-6 years with HR experience or related field required. The motion carried with a vote of 3 to 0 with Doug Barnett voting no.

Julane and Kyna reviewed the Draft Budget with the board.
