

COMMUNITY EDUCATION PROGRAM CONTRACT

THIS COMMUNITY EDUCATION PROGRAM CONTRACT, made and entered into this 19TH day of March, 2015, by and between **MARION COUNTY BOARD OF EDUCATION**, 735 East Main Street, Lebanon, Kentucky 40033, and **MARION COUNTY FISCAL COURT**, 223 North Spalding Avenue, Suite 201, Lebanon, Kentucky 40033,

WITNESSETH:

Marion County Fiscal Court recognizing that the Community Education Program is a vital part to the advancement of the community, does hereby agree to enter into a contract with the Marion County Board of Education with the following terms and conditions:

1. Provide the old "Shop Building" to the Marion County Board of Education and the Community Education Program for a period of one (1) year (July 1, 2015 - June 30, 2016), renewable each year on or before July 1;
2. Marion County Fiscal Court agrees to maintain insurance coverage on the "Shop Building;"
3. The Marion County Board of Education agrees to maintain the building in a reasonable condition and to pay all utilities associated with maintenance and occupancy of that building;
4. Marion County Fiscal Court agrees to reimburse the Marion County Board of Education for the cost of pest control services and custodial services for the Community Education Building;
5. Marion County Fiscal Court agrees to notify the Marion County Board of Education prior to March 1 of each succeeding year of this Contract so that the grant funds may be applied for to continue the Community Education/Adult Education/Family Literacy Programs/21st Century Learning Center;
6. Marion County Fiscal Court will allow use of the "Shop Building" facility for the Community Education Program at NO CHARGE provided that all terms and conditions are met.

Any changes to this Contract must allow one hundred twenty (120) days notice by either Party.
