For nearly 100 years, Metro United Way has been committed to bringing people together to solve community problems and that will never change. As you know, what has changed is how we help solve those problems by focusing more deeply on root causes, and we greatly value our partnerships to help reach our vision of a community whose people achieve their greatest potential through education, financial stability and healthy lives.

We've recently celebrated the final results of our 2014 annual community campaign - which continues to demonstrate the high level of trust Metro United Way enjoys in our community – raising \$27.65 million, an increase of 1.6% over the prior year (after deducting the 2013 CFC campaign dollars). However, we also experienced a growth seen nationally for donors who direct their gifts outside the community's human services network; locally, this increase was slightly more than \$750,000 Please know that we are already working on plans to increase awareness in our 2015 campaign of the benefit of undesignated dollars to support our work together.

This letter serves as notification of Metro United Way's 2014 investment in the amount of \$90,224.01 with your organization and we thank you for your continued partnership. The attached document details the funds allocated to you; please remember that our ability to pay out the investment dollars is contingent upon our ability to collect the funds pledged.
