

**APPROVAL OF A BG-4 FINAL APPROVAL AND PAYMENT  
APPLICATION TO THE CONTRACT FOR THE  
REPAIR OF THE PAUL LAURENCE DUNBAR HIGH SCHOOL  
SYNTHETIC TURF ATHLETIC FIELD  
BG 13-183**

**BACKGROUND AND RATIONALE:** Bid documents were prepared by the architect, Pearson and Peters Architects, for a contract for the repair of the Paul Laurence Dunbar High School synthetic turf athletic field. The contract in the total amount of \$723,723.05 (GC--\$327,823.05; DPOs--\$395,900.00) with Vescio SportsFields was accepted and approved by the Board in a meeting held on May 6, 2013 and construction began in May, 2013. The Department of Physical Support Services, the design consultants Pearson and Peters Architects, and the local building code officials have reviewed the progress of the work. Minor changes to the original plans and specifications have been necessary in order to: resolve unforeseen existing conflicts found during construction; comply with building code requirements; correct deficiencies in the plans; or to provide improvements over the original specification. The Board has approved 1 change order with zero dollar changes to the total construction cost. All work has been satisfactorily completed by the contractor. At this time, a BG-4 Final Approval and Payment Application Form are presented for acceptance of the work by the Board. **Remaining payments to the contractor shall not be made until all work is completed.**
