## Memorandum of Understanding Between REC Foundation and Jefferson County Public Schools

The Robotics Education & Competition Foundation (REC Foundation) is pleased that that Jefferson County Public Schools has agreed to be a district organizer and will share the excitement of STEM education and activities in the form of robotics education and competitions throughout your school district. Jefferson County Public Schools has been selected to receive a grant that will provide robotics equipment allowing each elementary, middle, and high school in the district to participate in the VEX IQ Challenge (VEX IQ) and/or VEX Robotics Competition (VRC) program and host official VEX IQ and VRC events in partnership with the REC Foundation. Jefferson County Public Schools will have perpetual use of the equipment outlined in this document until the district no longer participates in the VEX IQ or VRC programs. Once it has been established that your organization will no longer participate in the programs, the REC Foundation will make arrangements to pick up the equipment so that it can be made available to another deserving organization.

## Jefferson County Public Schools agree to the following:

- The equipment will be stored in a safe, clean location.
- The equipment will be used for official VEX IQ or VRC competitions or activities.
- The equipment will be returned to the REC Foundation once the organization decides to no longer participate in the VEX IQ or VRC programs.
- Jefferson County Public Schools will have 1 optional/practice competition starting in 2016-2017 school year along with 1 Regional Competition yearly starting in 2015-2016 school year.
- Jefferson County Public Schools will identify 2 schools to host competitions, and designate 2 "Event Partners" no later than October 1, 2016.
- Jefferson County Public Schools will have at least 30 schools participating by the end of the 2015-2016 competition season (registered by January 1, 2016).
- Jefferson County Public Schools will have at least 30 additional (new) schools participating by the end of the 2016-2017 competition season (registered by January 1, 2017) to bring the total schools participating to 60 by the end of year 2 of the 4 year grant. JCPS will continue to add 30 (new) or additional schools to participate in yearly Regional Competitions up to 120 schools by the end of the 4 year grant.
- Jefferson County Public Schools will have 100% school participation by the end of the 2018-2019 season (registered by January 1, 2019).
- Jefferson County Public Schools will participate in three scheduled WebEx meetings with the REC Foundation.
- Jefferson County Public Schools will agree upon a quarterly reporting schedule and format with the REC Foundation.
- Jefferson County Public Schools will coordinate a monthly teleconference to discuss training and support needed for sustainability with their REC Foundation Regional Support Manager, or an official REC Foundation designee.
