



**INTER-SCHOLASTIC ATHLETICS AND EXTRA-CURRICULAR
ACTIVITIES FUNDING AGREEMENT**

THIS INTER-SCHOLASTIC ATHLETICS AND EXTRA-CURRICULAR ACTIVITIES FUNDING AGREEMENT is made and entered into this 20 day of AUGUST, 2015, by and between **MARION COUNTY FISCAL COURT**, 223 North Spalding Avenue, Room 201, Lebanon, Kentucky 40033, and **MARION COUNTY BOARD OF EDUCATION**, 735 E. Main Street, Lebanon, Kentucky 40033.

RECITALS:

A. Recognizing that it has no formal county-wide youth and recreation program sponsored and administered by the County, and in an effort to promote activities for the youth of the County, the County deems it advisable and a benefit to the citizens of the County that it provide supplemental funding to the Board in support of inter-scholastic athletics and extra-curricular activities at the public schools in the County;

B. From time to time the County is presented with funding requests from various athletic booster organizations, schools clubs and sponsors of other school related activities. The County has heretofore assisted in the funding of many of those activities, although recognizing that there are likely other such activities which are equally deserving of funding but who have not made similar requests. The County further recognizes that the Board is in a much better position to recognize which activities are most deserving and in need of funding from year to year and should thus be the primary decision-maker as to the allocation of funding;

C. Questions have been raised as to whether the County=s funding of various activities implicates Title IX of the Civil Rights Act of 1964, as amended;

D. Following discussions at a duly scheduled meeting of the Marion County Fiscal Court, the County has allocated TEN THOUSAND DOLLARS (\$10,000.00) to be remitted to the Board to be administered in the support and promotion of inter-scholastic athletics and extra-curricular activities.

NOW, THEREFORE, the parties hereby agree as follows:

1. County does hereby grant to the Board the sum of TEN THOUSAND DOLLARS (\$10,000.00) to be used for the specific purpose of supporting and promoting inter-scholastic athletic programs and extra-curricular activities in the public schools of the County and shall be allocated among those activities in a manner which the Board, in its discretion, deems appropriate;

2. The Board shall advise all booster organizations, clubs, organizations and sponsors that future requests for funding should be made to the Board rather than directly to the County;

3. Board shall keep a proper accounting of all funding requests received and disbursements made and shall account to County by June 30, 2016, with a report of all such disbursements made;

4. The County shall not incur any expense or liability, assume any responsibility or have any obligation imposed upon it except as specifically provided for herein;
