

**APPROVAL OF A BG-5 PROJECT CLOSEOUT FORM**  
**RELATED TO THE CONTRACT FOR THE**  
**REPAIR OF THE PAUL LAURENCE DUNBAR HIGH SCHOOL**  
**SYNTHETIC TURF ATHLETIC FIELD**  
**BG 13-183**

**BACKGROUND AND RATIONALE:** Bid documents were prepared by the architect, Pearson and Peters Architects, for a contract for the repair of the Paul Laurence Dunbar High School synthetic turf athletic field. The contract in the total amount of \$723,723.05 (GC--\$327,823.05; DPOs--\$395,900.00) with Vescio SportsFields was accepted and approved by the Board in a meeting held on May 6, 2013 and construction began in May, 2013. The Office of Facility Design & Construction, the design consultants Pearson and Peters Architects, and the local building code officials have reviewed the progress of the work. Minor changes to the original plans and specifications have been necessary in order to: resolve unforeseen existing conflicts found during construction; comply with building code requirements; correct deficiencies in the plans; or to provide improvements over the original specification. The Board has approved the BG-4 in the amount of \$723,723.05 at its meeting held July 27, 2015. The residual fund balance will be applied to future debt service or to the next District Facility Plan project. At this time the BG-5 Project Closeout Form closing out all construction contracts related to this project is presented for approval.
