McCracken County Schools Request of Waiver to 704 KAR 3:285, Section 9

McCracken County Schools is requesting a waiver to 704 KAR 3:285, Section 9 pursuant to our conversations with KDE and as permitted by KRS 156.160, Section 2, Subsections a-c.

McCracken County was awarded \$58,036 for Gifted and Talented Education for the 2014-2015 fiscal year. 704 KAR 3:285, Section 9 requires that districts use 75% of GT awards to fund certified GT personnel in the district. In an attempt to provide quality service by GT certified personnel to our 1,344 identified students, we have tried a number of different options over the past several years. During the 2014-2015 school year, McCracken County allocated 100% of the GT award directly to school councils for direct services to students by GT certified personnel.

For the 2015-2016 school year we would like to have other options on spending our GT money that do not require us to spend this money on personnel, but that will give us the freedom to provide GT services in other ways. This is the basis of our waiver.

We believe that using the entire \$58,036 on students will allow us to better meet the needs of our GT students. Our rural location prohibits many students from access to museums, art galleries, plays, science exhibits, and the like. Even if these programs were available, our 44% Free and 6% Reduced Lunch numbers for the district would limit parents' financial ability to access those opportunities. Allowing our schools the opportunity to use the entire GT award toward experiences relevant to individual student need will have a more profound effect on the GT students in our district than a personnel allocation. We foresee using the entire award not only to take our students outside the district, but also to bring in quality presentations geared toward meeting the specific needs of all our GT students. The requirement of 75% of the GT award for GT certified personnel has prevented us from providing quality services by talented artists to our gifted Dance, Drama, Visual Art, or Music students. Again, we believe using the entire grant to support students rather than personnel is the best use of these funds.

The district could very easily use 75% of the \$58,036 of our award to partially fund a district-wide teacher with GT certification. However, when you look at the number of identified students as well as the diverse needs of these students in a K-12 perspective, the quantity and quality of services that are provided becomes very limited. If granted, McCracken County would continue to allocate 100% of the GT award directly to the schools. However, School Councils would have flexibility in providing high quality opportunities to their specific identified population. We hope the Kentucky Board of Education will see that this waiver is a request made in the best interest of the GT students of McCracken County Schools. If this waiver is granted, our schools would have the freedom to use 100% of our GT award to meet the needs of their gifted students using existing personnel and providing many more opportunities than previously allowed.
