LEAD Reports Due Soon

Districts are reminded that October is the month during which the LEAD report must be corrected, completed, and submitted to EPSB. November 1, 2015, is the sign-off date, but districts may sign off earlier if all errors have been corrected. Superintendents should take a moment this month to speak with the LEAD coordinators and view the Preliminary Audit Report, which will show any critical errors such as out-of-field teachers, new teachers not yet in KTIP, and those with expired certificates. NBCT Applicants May Qualify for Reimbursement

The Kentucky Network to Transform Teaching (KYNT3) is offering financial assistance to teachers pursuing National Board certification who are from schools without National Board Certified Teachers.

To help achieve the goal outlined in a Kentucky statute of having one National Board Certified Teacher in every Kentucky school by 2020, KYNT3 will reimburse qualified candidates for up to \$275 in out-of-pocket expenses after the submission of one NBCT component for as long as grant funding allows and in the order applications are received.

New Record for the Division of Certification

Typically, summer has always been the busiest time of the year the Division of Certification. The past two years, however, have been record setting years for the Division of Certification. From January 01, 2014 to September 15, 2014, the division processed 103,445 credentials. This year from January 01, 2015 to September 15, 2015, the division has processed 127,398.

Disciplinary Regulation Rewrite Committee

16 KAR 1:030 Procedures for certificate revocation, suspension, reinstatement and reissuance, and application denial was presented to the EPSB at the August 10, 2015, Board meeting. The EPSB held a special called meeting on Monday, September 14, 2015, to further review the draft regulation and discuss any changes that may be necessary. The regulation is scheduled to be presented again at the October 12, 2015, regular Board meeting. Once the Board takes action, the regulation will go through the required Legislative Research Commission process for approval.

Superintendents now have access to the system and have the ability to assign a person within the district (e.g., a human resource director) to be her/his designee to submit items. We ask that you start using this system to report educator misconduct. When a report is submitted, the person filing the report receives a confirmation email.
