Mrs. Duncan requested the Board see average daily attendance data for the past three years and any data that shows the impact of Positive Behavior Interventions and Supports (PBIS) and Student Response Teams (SRTs) on test scores and/or the TELL survey. She suggested the data be used as measures for evaluating this program and that the district track acts of violence and/or harassment. Discussion ensued.

A motion by Mrs. Linda Duncan that the Board of Education approve Agenda Item VIII.P.5. Acceptance of School Climate Transformation Funding from the U.S. Department of Education to accept a School Climate Transformation Grant Year Two Continuation Award totaling \$749,547 from the U.S. Department of Education contingent upon the provision of average daily attendance data for the past three years, data that shows impact on test scores and the TELL Kentucky survey, and data tracking the number of acts of violence and/or harassment to be used as measures for evaluating the program failed for lack of a second.
