## District Reports on Grants

Several districts reported that they are working on the $21^{\text {st }}$ Century Community Learning Center grant. These include Bellevue, Pendleton County, and Erlanger-Elsmere. Vicki Dansberry reported that she is working with Bracken County on the KySTE Grant and with Erlanger-Elsmere on the Laura Bush Librarian Grant, all due in mid December.

## Grant Status

Learn and Launch - Anna Marie Tracy reported that Boone County had been awarded this grant from KDE for four schools in her district. Vicki commented that Boone County was the only district to receive this award in the state. Congratulations to Anna Marie and Boone County Schools.
$\mathbf{2 1}{ }^{\text {st }}$ CCLC - Vicki said that she had gone to the KDE workshop for this grant and is ready to help any districts and partners to plan and write the grant. It's due in mid-January. She also recommended that districts and their partners
send people to the upcoming workshop. Last year our Consortium districts and their partners won 8 of these grants for after-school services, and it would be nice to see that kind of success again!
Assessment for Learning - Vicki distributed a worksheet about the plan for this $\$ 225,000$ two-year grant. It is a potential window into further Gates-related funding. The group discussed the plan thoroughly and made some changes that will be reflected in the proposal. It will be submitted by Dec. 10.

## Grant News

I3 - Vicki mentioned that our I3 grants that had been requested for full applications were not, in the end, funded. Vicki will review awarded grants and provide a summary in the future.
Upcoming Speakers - Jen Hansert from Brighton Center; Tim Hanner of Navigo and a representative from Torchprep; Ed Griff, a researcher from UC; and Patricia Kanappel of REL Appalachia will be speakers in future meetings.
ESSC Update - Vicki spoke with the project officer about potential for the US Department of Education to release the counseling grant this year. The project officer said they don't know yet whether it will be funded, but they are working on developing the RFP as if it will be. The project officer also said the RFP will be ready to distributed in December, but, depending on what happens with the budget, the release may be delayed or not happen at all. Vicki is watching for it.

SAM.gov - Any district that is planning to apply for $21^{\text {st }}$ CCLC MUST have a Sam.gov registration! Please check today to see if your registration exists and is up-to-date. Even if you are not applying for this funding, it would be a good idea to register at www.sam.gov asap. The process can take several weeks and it is better to have it in place while you are not under the time pressure of a grant. If you need assistance, contact Vicki.
