

MEMORANDUM OF AGREEMENT

This Memorandum of Agreement ("MOA"), dated this 12 day of January, 2016, is made and entered into by and between General Electric Company, through its GE Appliances operating component, ("GE"), Amatrol, Inc. ("Amatrol"), and the Jefferson County Board of Education, doing business as the Jefferson County Public Schools ("JCPS"), hereinafter the "Parties".

WITNESSETH:

WHEREAS, manufacturing companies provide high paying jobs for highly skilled workers; and

WHEREAS, the Parties wish to make available to high school students information and opportunities that will enable them to explore manufacturing as a career choice; and

WHEREAS, the Parties have identified certain equipment and technologies commonly used in today's manufacturing enterprises; and

WHEREAS, GE and Amatrol wish to donate equipment, curriculum and services that will introduce students to equipment and technologies that will expose students to careers upon graduation from high school and to post-secondary educational opportunities, including the Kentucky Federation for Advanced Manufacturing Education (KY FAME) or other-post secondary opportunities;

NOW, THEREFORE, in consideration of the mutual benefits to be derived from this MOA and in consideration of the covenants, conditions, agreements and understandings hereinafter set forth, the Parties agree as follows:

1. GE will make a donation of \$22,000 to JCPS to be used for the purchase of a Hydraulics Trainer for Jeffersontown High School for use in the school's Industrial Maintenance Technician program. The equipment specification and other details are set forth in Exhibit A, attached hereto.

2. Amatrol will donate to JCPS-
 - A. interactive multimedia software that aligns with the equipment described in 1, above, valued at \$3,213.00 to be used at Jeffersontown High School; tuition-free training for use by Jeffersontown High School instructors in attending training classes at Amatrol Technical Training Institute scheduled for the summer of 2016; and a banner (see Exhibit B, attached) valued at \$500.00 to be displayed at Jeffersontown High School in the area used by the school's Industrial Maintenance Technician program; and
 - B. cause Technical Training Aids, Inc., the authorized Amatrol distributor for Kentucky, to provide equipment installation and familiarization training for instructors at Jeffersontown High Schools valued at \$800.00.
3. JCPS, on behalf of Jeffersontown High School, will -
 - A. receive and acknowledge the \$22,000 donated by GE
 - B. purchase the Hydraulics Trainer from Amatrol and make arrangements for payment;
 - B. provide for the proper installation of the Hydraulics Trainer equipment;
 - C. provide support for a Jeffersontown High School teacher to participate in equipment installation and training provided by Amatrol;
 - D. install a banner (see Exhibit B, attached) at Jeffersontown High School in the area used by the school's Industrial Maintenance Technician program; and
 - E. at a meeting of the Jefferson County Board of Education recognize GE and Amatrol for their donations.
4. This MOA shall be modified and/or amended only by a written amendment executed by all parties to this MOA.
5. The parties agree that the laws of the Commonwealth of Kentucky shall govern all questions as to the execution, validity, interpretation, construction and performance of this MOA.

6. The date entered on page 1 hereof is the effective date of this Agreement.
