 Describe how your request meets the Crusade's mission: To help children overcome physical, mental, emotional and medical challenges.

This request meets the Crusade's mission to help children overcome physical, mental, emotional, and medical challenges by providing students with disabilities access to the Expanding Expression Tool Kit, a system that would help them quickly build oral and written language skills. Serving more than 2,000 Jefferson County Public Schools (JCPS) students with disabilities, this project would help those who struggle in these areas overcome barriers to academic success. The Expanding Expression Tool Kit offers strategies to increase general descriptions, write from prior knowledge, summarize, and define. It can be used across a wide range of grades and content areas.

JCPS Communications Disorders Program proposes purchasing 40 Expanding Expression Tool Kits, which use a multi-sensory approach for improved oral and written language among students who struggle in these areas. Each kit includes an Expanding Expression Tool that provides students a hands-on approach to describing and defining. The tool is color symbol coded. Students learn the code and from this code are able to provide detailed descriptions including the following elements: the category the item belongs to, the function of the object, the appearance, what the item is made of, the parts of the item, and its location. As a mnemonic device, the tool provides visual and tactile information, which facilitates improved language organization. The Expanding Expression Tool Kits also include a manual, stickers for written expression, object cards for describing activities, a poster, a dice game, instructional icons, and lesson plan prompt cards.

Many of JCPS' Speech Language Pathologists (SLPs) attended training at the annual Kentucky Speech Language Hearing Association conference in February 2015 and heard creator Sara Smith present on the Expanding Expression Tool Kit. The SLPs were excited as this is one of the few items available that serves a wide-range of ages from three to 21, is not linked to one particular curriculum but instead can be used in conjunction with any curriculum, and actually teaches students compensatory strategies to use not only during speech language therapy but also in their regular classroom environment. The Expanding Expression Tool Kit is rooted in research-based philosophies including the use of multi-sensory learning situations, consistency over multiple years, organizational techniques, and ease of incorporation into all learning opportunities.



Twenty of our 125 SLPs are using Expanding Expressions at their schools. Three SLPs have trained their entire school in the Expanding Expressions technique and one additional SLP has trained interventionists at her school. Using this philosophy, our measurement of success is use of this tool, not only with SLPs, but across settings and teachers, allowing special need students an opportunity to better express their wants, needs, and knowledge.
