We will use the TABE test as an initial assessment and then students will be reassessed after 40 hours of instruction. Level gains will be recorded according to the NRS (National Reporting System).

We will use the GED Ready test as a measure of students being prepared to take the actual GED. In Kentucky GED students must pass each of the 4 GED test with a 150 before they are allowed to take the actual GED test.

We will also use the NCRC test as a measure of a student's success and preparedness for employment. Student will score either a silver or gold.

Our ELL student's initial assessment will be given using CASAS with reassessment given after 40 hours of instruction.
