G. INTRODUCTIONS, RECOGNITIONS, ACKNOWLEDGEMENTS AND RESOLUTIONS: Teacher Representative - Laura Roche'- Beaumont Middle School

Laura Roche' is currently the French teacher at Beaumont Middle School. She has been an employee of the Fayette County Public School system since 2010. Prior to then, she was the French teacher at Anderson County High School for 18 years. She serves as the Department Chair of Arts and Humanities, Facilitator of the Global Competency and World Language Program Review, and Sponsor of the French Club with over 100 members each year! Ms. Roche' recently completed her Doctorate of Education at the University of Kentucky and was named 2015 state French teacher and world language teacher of the year. She is married with one child and enjoys her family time at the lake on the weekends and attending yoga classes

Student Representative - Sarah Hoffmann - Paul Laurence Dunbar

Sarah Hoffmann is the daughter of Russell and Julie Hoffmann. She is a senior in the Math Science and Technology Center program at Paul Laurence Dunbar High School. For her 360-hour capstone project, she is completing a project on cognitive categorization in early infancy. She is the president of Dunbar's Student Y, and served as a student Justice on the model Supreme Court of Kentucky at this year's Kentucky Youth Assembly. Sarah is also Vice President of Dunbar's Student Council and is a member of the Debate Team. Recently, she has been working with the nonprofit Inspire Kentucky, and has registered over one hundred of her classmates to vote. She hopes to study political science or public policy in college next year.

G.2. Student Performance

Performance, Ashland Elementary

Melissa Bacon welcomed the Ashland Elementary FACT group, which stands for "Fine Arts Cultural Track." These dance, drama, and chorus students are presenting a scene from their winter show, "You've Got Mail." They are under the direction of teachers Ashley Oldham, Kathleen Balling, and Shanon Medley.

G. Recognitions

- a. Lucas Etter, a ninth-grader at Henry Clay High School, has set what is largely considered the most coveted and most recognized world record in the speed cubing community. His time for a single solve of a 3-by-3 Rubik's cube was a blazing 4-point-9 seconds. Lucas set this record during a World Cube Association-sponsored competition outside of Baltimore, Maryland. His time will be a Guinness World record as well. Lucas practices various cubes every day, but he specializes in the 4-by-4, the 3-by-3, and the 2-by-2, for which he holds the world record average. He attributes his success to algorithm memorization, spatial skills, muscle memory, and lots of practice.
- b. Five talented FCPS students received top honors in violin and piano competitions sponsored by the Kentucky Music Teachers Association and the Music Teachers National Association. Earning honors at last month's state conference were:

William Auer, a sixth-grader from SCAPA at Bluegrass, for first place in junior high violin;

Alexander Auer, a sixth-grader from SCAPA at Bluegrass, for second place in junior high violin; Amy Wang, a junior at Paul Laurence Dunbar High School, first place in high school piano; Andy Du, a freshman at Dunbar, second place in high school piano; and Erik Han, a freshman at Dunbar, second place in junior high piano. The Music Teachers National Association, which was founded in 1876, is the oldest professional music association in the United States.

- c. A team from Locust Trace AgriScience Center won the Kentucky FFA Veterinary Science career development event last month at Murray State University and will advance to national competition next fall in Indianapolis. Alli Rankin, Paul Wright, Caroline Wright, Shawndulynn James, and Aracely Marin had studied since February to prepare for the state contest. It included tests on anatomy, medical math, parasitology identification, and tools identification, and two hands-on veterinary skill tests.
- **d.** Edythe J. Hayes "B-team" upset top-seeded Lexington Traditional Magnet six-to-nothing as their championship game went into overtime. The Panthers are coached by Nicholas Payne, Marty Parks, and Jason Pack.
- e. Jessie Clark Middle School's varsity squad won the 2015 "A-team" city football championship capping an undefeated season with a record of 10-and-0. This marks Jessie Clark's third consecutive city championship. The Eagles are coached by Eric Sclarb, Bob Vyverberg, Jeremy Armstrong, Stephon Smith, Bob Crouch, and James Yeast.
- f. The Henry Clay boys' soccer team was runner-up in the 2015 Kentucky High School Athletic Association's state championship after falling three-to-nothing to Covington Catholic in the finals. The Blue Devils were shut out for only the second time all season and finished with a record of 23three-and-one. Henry Clay had advanced to the state tournament for the first time in four years after edging Paul Laurence Dunbar one-to-nothing for the Eleventh Region title. The Blue Devils are coached by Tim Bernardi, Jason Behler, and Kristan Junker.
- g. Sam Simpson, who has taught health and P.E. at Henry Clay High School since 1993, received a "Caring Coach of the Year" award from Dove Men+Care Deodorant and the College Football Hall of Fame. From hundreds of nominations across the country, the Blue Devils' head football coach was among four youth and high school coaches selected for displaying passion, character, determination, respect, and encouragement, and for making a lasting impression on their players and colleagues congratulated Sam at a surprise announcement last month. He is also invited to Atlanta for this Friday's national awards ceremony, including the unveiling of a year-long exhibit dedicated to each of the four winning coaches.
- **h.** Laura Roche'Youngworth of Beaumont Middle School received the 2015 Outstanding Teacher Award from the Kentucky World Language Association. Laura chairs the arts and humanities department at Beaumont and serves as president of the Kentucky chapter of the American Association of Teachers of French. She is in her 24th year of teaching French. Laura graduated from the University of Kentucky with a bachelor's degree in English, French, and Secondary Education, and then earned a masters and Rank One in Curriculum and Instruction.
- i. The National Blue Ribbon Schools Program honors schools whose students achieve at very high levels or have made significant progress and helped to close gaps in achievement, especially among

disadvantaged and minority students. It's a privilege tonight to honor SCAPA at Bluegrass as one of the two-hundred-and-eighty-five public schools in the nation to receive Blue Ribbon honors this year. Principal Beth Randolph, former principal and now administrative dean Marilynn Cunningham, and teacher Robin Barker traveled to Washington, D.C., last month for the Blue Ribbon awards ceremony.

1. Student Achievement Novice Reduction

Discussion:

Marlene Helm shared an update on Student Achievement Novice Reduction plan. She stated the school board will have a "lunch and learn" meeting Dec. 17th to review the next proposed CDIP with its six goals all of which are aligned with the Student Achievement Novice Reduction plan. Marlene Helm described the Comprehensive District Improvement Plan or CDIP as "a guiding document to help move our district forward." After winter break, school leaders will attend board meetings to share their specific plans to improve "as is" status and move students toward proficiency.

2. Equity Council Report

Discussion:

Darryl Thompson provided an update on the Equity Council Report. He stated the Equity Council has four newly elected or appointed members who will serve two-year terms: Roger Cleveland, Andrea James, Ron Mack, and Sharon Mofield-Boswell. He asked the board to renew its charge to the council in the New Year in order to revitalize the group and encourage these new members. In addition, Thompson noted the Equity Council's Top Ten recommendations are embedded in the proposed CDIP.

3. Construction Progress Report

Discussion:

Myron Thompson shared an update on construction projects including an overview of the work completed to date. He reported Squires is 70% complete. The new elementary at Passage Mound is 50.93% complete, the new elementary at Georgetown Road is 49% is complete and set to be completed in July, 2016. The new high school at Winchester Road is 21% complete.

Discussion:

The board discussed a proposal to allow Junior Achievement (JA) of the Bluegrass to renovate a portion of the old Linlee School to create a "BizTown/Finance Park" designed to provide hands-on learning experiences in civics and financial literacy for elementary, middle and high school students in Central Kentucky. JA plans to spend \$2.2 million on the project. Board member Doug Barnett voted against the measure, saying that the board should wait until January to approve the JA partnership, because that transition is linked to reuniting Booker T. Washington Academy in the 707 Howard Street building, and moving The Learning Center to the facility at 475 Price Road. Those two moves will come before the board

for approval in January. Doug Barnett said the board should take action on all three at once. The proposal failed by a vote of 2 to 1, with Melissa Bacon and Amanda Ferguson voting yes and Doug Barnett voting no.
