Dayton High School SBDM Minutes February 17, 2016

Principal Jeremy Dodd called the February 17th meeting to order at 4:00 pm in the Dayton High School Library. Public Comment

- Barb Lund said she has heard that some people are saying they are not getting the automated calls.
- People have asked about why the grading scale does not apply to Lincoln. Mr. Dodd explained this is a Site Based decision, and Lincoln's Site Based Council would have to vote to change their grading scale.

Committee Reports

Arts

- Cheryl Spahr said she has 5 students failing, which is due to missing or incomplete work. She talked about the Fine Arts Festival which is March 24th from 5:30 to 7:30. There will be a dinner and art pieces on display. The Band will have a Coffee Shop setting and there will be a performance by the Drama Class.
- Mr. Klopp stated he has no failures. He also asked that scheduling issues not exclude band because of conflicts.

Math

- Ms. Goetz talked about the possibility of flipping math to Algebra I, Algebra II, and then Geometry instead
 of Algebra I, Geometry, Algebra II. This was set this way because of ACT. She also asked if Pre-Algebra
 could be counted as a math for Freshmen. Ms. Goetz has 1 failure in 8th grade Honors and 8 in her other
 classes. Not making up work and absences are the main reasons.
- Ms. Goetz reported for Amy Bauereis stating she had 2 failures. Her failures are due to absences.
- Ms. Goetz reported for Mr. Bird stating he has 6 failures, Ms. Begley has 9 failures, and Mr. Hunt has 4 failures. All of these seem to be due to missing, or incomplete assignments and absences. Everyone is doing parent meetings, calls home, and after school help.

Old Business

Mr. Dodd discussed the 30-60-90 Plan and stated it is unchanged at this time.

New Business

- Mr. Dodd stated that since the recent COMPASS exams we now have 2 more college ready students and we also have 2 more Career ready students. We will know more by the end of March.

- Mr. Dodd stated the AdvancED Diagnostic Review is complete and we are just waiting on the results, which won't be in for 5 to 8 weeks.

- Mr. Dodd went over Ms. Chan's SBDM/Principal Agreement. Angie Buschle made a motion to sign the agreement. Angela Gonzalez seconded the motion. The motion carried. Mr. Dodd signed the agreement.
- Mr. Dodd went over Policy 8.04 about attendance and graduation. It was decided that if they have the
 grades to graduate, attendance shouldn't stop them. Barb Lund made a motion to remove this policy.
 Angie Buschle seconded the motion. The motion carried. The policy is to be removed from the binder.

- Bonnie Sizemore made a motion to extend the meeting at 5:30. Angie Buschle seconded the motion. The motion carried.
- Mr. Dodd went over the Safe School Report.
- It was brought up that since we have a policy for high school credits for Algebra and Spanish, could we have a credit for Digital Literacy. We will think about it and put it on next month's agenda.
- Mr. Dodd went over the SBDM Budget. It was brought up to add \$500 to Office Supplies. Barb Lund made a motion to add the \$500 to Office Supplies. Angie Buschle seconded the motion. The motion carried.
- We talked about SBDM Elections. Elections need to happen before May 1st.
- Mr. Dodd mentioned the AD position has been posted. It was discussed that it should be someone in the building.
