Grant Opportunity for Summer Learning for Novice Reduction

The Kentucky Department of Education is pleased to make available to Priority Schools additional SIG (School Improvement Grant) dollars aimed at assisting schools in Novice Reduction work through a summer learning grant opportunity. These grant dollars are being made available to assist Priority Schools in reducing the number of students scoring at the novice level and improving overall student achievement. **These funds are intended to target specific supports and interventions aimed at reducing the numbers of students scoring at the novice level in Priority Schools through summer learning programs; however, these funds may be used during the school year to support other learning opportunities.** Funds are available to both middle schools and high schools. These funds must be expended with all bills paid by September 1, 2016.

Priority Schools and their superintendents should analyze current data to best determine a plan for summer learning based on the needs of their students and staff as demonstrated through achievement data and diagnostics found within the Novice Reduction web pages. These funds may be used across grades to increase the likelihood of students in every grade to achieve proficiency, through programs for students and/or professional learning for school staff.

Review plans, goals, and results from the previous grant submitted as you determine a design for the new 2016 proposal. The anticipated top award for this year is \$30,000.00 per school. The following are suggestions and focus areas to consider when crafting your proposal:

- Summer learning for students, or professional learning for staff that utilizes one or more of the eight Novice Reduction [Key Core Work Processes](#). This support may utilize guidance, materials and resources from one or more of the four areas of Novice Reduction: [Standards and Curriculum Support](#), [Instruction](#), [Continuous Improvement and Assessment](#), and [Environment and Support](#)
- Transportation for students
- Stipends for teachers to facilitate learning and monitor student progress (in keeping with local board policy)
- Communication to community for advertising purposes
- Tech software for curriculum and instruction development and support for summer programming (should **not** be used to purchase devices such as laptops or tablets)

Schools and district support personnel should collaborate to determine needs. In addition, your Educational Recovery Director will be able to provide further assistance and guidance through this application development process.

****For summer learning programs for students, the majority of dollars spent should benefit students and limit large dollar amounts for stipends given to teachers and administrators monitoring the implementation. Funds should be aimed at student-centered initiatives or staff professional learning for the purpose of reducing the numbers of students scoring at the novice level.**

Proposals will be reviewed by KDE and award notices will be made by Friday, April 22, 2016.

All funds must be spent with bills paid by September 1, 2016.
