**Recommendation/Motion:** Confirm the emergency previously declared by the Superintendent as provided by KRS 45A.380, and approve a BG-1 Project Application for the radon remediation projects at Bryan Station High School, BTW-I (The Learning Center), Harrison Elementary, Leestown Middle School, LTMS, Mary Todd, Russell Cave, SCAPA and Sandersville in the amount of \$571,846.50 (Five Hundred Seventy-one Thousand, Eight Hundred Forty-six Dollars and Fifty Cents) and approve Tate Hill Jacobs Architects as the design consultant, subject to the approval of the Kentucky Department of Education, District Facilities Branch, per the provisions of 702 KAR 4:160.

**Background/Rationale:** A series of recent events, including those that led to the radon mitigation at Locust Trace Agriscience Center, has brought up the subject of radon levels in our schools. A project was undertaken to test all schools not recently addressed. Through multiple rounds of testing, the radon levels in portions of nine schools were found to average above the 4 picocurie per liter level that the Environmental Protection Agency (EPA) recommends for indoor air quality, when the buildings were occupied. FCPS plans to complete the radon mitigation during Summer Break. In accordance with KRS 45A.380, on March 3, 2016, the Superintendent has declared this project to be an emergency in nature. The concern for the health, safety and welfare of the students, faculty and staff requires FCPS to move forward quickly to complete the radon mitigation system installations and to provide the indoor air quality recommended by the EPA during Summer Break. This modification of a building system requires a BG-1 Project Application. Tate Hill Jacobs Architects was the design consultant for the original construction and has agreed to assist. A cost estimate as indicated below has been provided for use in preparing the BG-1. The work is planned
