6 RELATES TO: KRS 156.070, 156.160

7 STATUTORY AUTHORITY: KRS 156.070, 156.160

8 NECESSITY, FUNCTION, AND CONFORMITY: This is to repeal administrative regulation 704

9 KAR 3:340, Commonwealth Diploma Program. The regulation contained a sunset provision,

10 ending the Commonwealth Diploma Program in the 2012-2013 academic year. The regulation

11 describes guidelines for a program which no longer exists and is, therefore, no longer necessary.

12 Section 1. 704 KAR 3:340 is hereby repealed.

(a) What this administrative regulation does: This regulation repeals 704 KAR 3:340, Commonwealth Diploma Program.

(b) The necessity of this administrative regulation: 704 KAR 3:340 should be repealed because it describes a program which no longer exists. The regulation contained a sunset provision ending the program in the 2012-2013 academic year. Therefore, 704 KAR 3:340 is no longer necessary.
