- > Understanding of assessment data at the school, district, and state levels and opportunity gaps
- Information on how to use the data to participate in efforts to improve student outcomes
- Knowledge of how to partner with school administrators, teachers, and other parents to improve student outcomes
- > Skills to enhance their ability to lead and communicate with a diverse group of people
- Connections to an existing network of parents and community leaders committed to public education
- > Meals and materials provided at no cost.
