**BACKGROUND AND RATIONALE:**

Due to traffic wear and sunlight exposure, parking lots need to be re-stripped every five years. Sealing parking lots helps eliminate moisture forming under asphalt. During freezing temperatures the moisture freezes, causing crumbling. Sealing also extends the life of the asphalt, thereby saving costs for repair.

## **2. Bid 12-14 – MEDICAL SERVICES**

### **BACKGROUND AND RATIONALE:**

This medical services contract is a part of the District's occupational health and safety program implemented through Human Resources, Transportation, and Risk Management and Safety. Baptist Health, the current contract holder, has agreed to keep the same pricing if the contract is extended for one additional year. Medical costs are increasing at an approximate rate of 6% annually. This extension will be the second year of three-year option. Baptist Health medical services have been excellent. To provide continuity, assure reliability and quality, it is recommended that the Board extend the current contract with Baptist Health for one year, from July 1, 2016 through June 30, 2017.
