### **Building Leaks**

Completion Date: Complete per Morel Action Required By: SCB/Morel

All building leaks and interior repairs are complete. Two issues were observed during recent rain events that will be addressed by SCB/Morel Construction.

- 1. Leaking has been noted from wind-blown rain at the Automotive Pathway vehicle exhaust hood. SCB will consult with STW to determine if a backdraft damper can be added to the exhaust hood.
- Front canopy downspout stopped up due to debris and water was observed in the front
  vestibule near the WKU Administration Suite. SCB and Morel discussed adding an overflow
  scupper to the front canopy to prevent water from overwhelming the canopy flashing and
  entering the building should the canopy drain become obstructed in the future.
