Regional School Programs:

- Our site visit for Alternative School of Distinction went very well & we have already received
 positive feedback in regard to our authentic program through a collaborative effort. Thanks to
 the districts who were represented—this truly was impressive to the interviewing group from the
 state.

NKCES P.O.P. Tours (problem of practice tours)

- The Bellevue POP Tour was a huge success! We had over 7 districts participate for a total of approximately 15+ educators. We began the tour by loading onto the awaiting school bus which provided a time for the group to talk and ask questions as we drove to the schools. The visit began with Superintendent Smith sharing his vision and the work around PEBC in their schools. We then visited classrooms in small groups to see the PEBC framework in action with students leading the academic discourse within classroom cultures that fostered student led learning/questioning/discussion. The tour concluded with a panel discussion of key teachers and leaders that were able to answer the groups' questions as we reflected on our visit. To say the least, it was a great day in Bellevue for our P.O.P. Tour!
- We had a small group visit iLEAD Academy on May 3 where students design their schedule and choose how, what, when, and where they will learn. They enjoyed the visit and were inspired to explore an academy where students participate in four years of progressive work-based learning experiences and develop the skills to succeed in every workplace.

ISLN (APRIL) at Gateway: Many districts are planning for "next steps" in curriculum alignment & refinement. The professional learning consortium requested a time to share out documents, tools, processes, resources, etc. to support this process. Everyone did a fabulous job of sharing their resources and supporting each other as we are all in different places in the process yet bring different experiences/tools to the table that are all valued. EL Meeting: This group has been meeting to discuss a funding structure for 20-16=17 and service needs. They will be having another meeting to discuss possibilities to support the requirements of the program/meeting student needs

PROFESSIONAL LEARNING CONSORTIUM

Regional PLC Design (see attachment): In an effort to provide collaboration between educators to impact student instruction, NKCES is adding new groups to the list of available PLCs for our region. These groups will be self-guided as the groups set their own agenda and share ideas, resources and collaborate to enhance instruction.

Summer PL Opportunities:

 New Teacher Academy: The Professional Learning Consortium has requested that a summer session be created for new teachers with follow-up sessions throughout the year to provide support and build regional capacity in our beginning educators.

Update on Facility: SHP has provided free services and created an exceptional presentation to help us in our decision making process in regard to the building. SHP Leading Design met with the Executive Committee (facility committee) to share four potential development scenarios relative to future facility decisions for the NKCES Administrative offices, professional development/training spaces and the alternative school. Their effort include options on cost and the overall feasibility of each scenario – ultimately providing NKCES with the information necessary to make a well-informed decision pertaining to the short-term and long-term viability of their facilities in a 21st Century educational environment. **An RFP would be created before any work would be completed.** *After the presentation the board asked me to meet with Dr. Poe to review the proposals and this meeting was held on May 5th.

Pre-K Works Steering Committee: I am working with this group and have contacted Commissioner Pruitt to discuss the recent \$7,500,000 in funding for preschool. As the decision is still in developmental stages as to how these funds will be allocated, I have shared with the commissioner that NKY has many examples of success and we would be willing to help with initial discussions as advocates for early childhood.

Grant's Consortium: This group has been very active in the past month and has many grants in the works. I have been meeting with the group when available and also meeting with Vicki Dansberry to discussion resources, needs and appropriate measures for the suggested projects.

RTI CONFERENCE CALL: Dr. Poe connected me with Dr. Wisniewski with RTI(Research Triangle Institute) and I shared our PLC Design for 2016-17 and they are interested in exploring funding for a partnership to help us grow our PLCs and they would use this project as a research project for RTI on the impact of building/sustaining professional learning.
