THIS MODIFICATION, made and entered into as of the 15th, day of June, by and between the KentuckianaWorks Foundation, Inc., 410 West Chestnut Street, Louisville, Kentucky 40202 ("the Foundation"), and the Board of Education of Jefferson County, Kentucky, 3332 Newburg Road, Louisville, Kentucky 40232, ("the Contractor") as registered with the Kentucky Secretary of State.

WITNESSETH:

Modification to Previous Agreement:

Pursuant to Part 11, "Modifications to Agreement," the parties to this Modification Agreement No.2 mutually agree to make the following modification to the original agreement previously entered into by and between the Foundation and the Contractor in Contract No. <u>340-160-15</u>.

The purpose of this modification is to make the following adjustments:

1. On page 1, agreement 1.2 Duration of Contract, shall be replaced with the following statement:

This contract shall begin the 1^{st} day of July, 2015 and continue until the 30^{th} day of September 2016.

However, in the event that, during the term of this Agreement, the Louisville/ Jefferson County Metro Government ("Metro Council") fails to appropriate funds for the payment of the Foundation's obligations under this contract, the Foundation's rights and obligations under this contract shall terminate on the last day for which an appropriation has been made. The Foundation may deliver notice to the contractor of any such non-appropriation not later than 5 days after the Foundation has knowledge that the appropriation has not been made.

2. On page 14, agreement 9.1 Amount of Compensation, the following not too exceed amount has changed and should be replaced with the following statement:

The Foundation agrees to compensate the Contractor, subject to actual availability of funds and proper documentation of expenses incurred and/or activities performed. The total amount of compensation payable under this Agreement to the Contractor shall not exceed the sum of \$246,464.00 for delivery of services, as specified in the Program Narrative and Budget, more fully described below.

3. On pg. 22, Budget Narrative, section C., changes to the fiscal year end dates should be reflected, and replaced, by the following statement:

The Contractor's fiscal year ends on <u>September 30th</u> and any required audit, or listing of Federal funds received in the fiscal year, must be submitted to the Foundation, at the address given in Section III above, within three months of that date. If for any reason a required audit will not be completed within the three-month deadline, the Contractor must request in writing an extension of the stipulated deadline or will be considered in violation of this Agreement so as to be ineligible for compensation until the violation is rectified.

4. On page 26, replace the set budget with the following budget (as modified). The "not-to-exceed" amount increases from \$203,561 to \$246,464.
