#### VI. Superintendent's Report

Dr. Hargens discussed two forums where employees could ask questions directly to the independent consultants that conducted the salary study. She then informed the Board that they would receive a budget update where they would hear from Chief Business Officer Tom Hudson regarding where the district is and where it is going. She stated that they have outlined expenditures that align with the mission and the strategic plan. She discussed the Superintendent's Summits regarding the creation of a behavioral management system for the district. She announced that she is recommending a line item be added to the tentative budget totaling up to \$5 million to support teachers and students as well as the design of a behavioral support system. She congratulated the Class of 2016 and stated that she is proud of them and looks forward to celebrating with them this week. She concluded her report by recommending the consent agenda for approval.

#### VII.A. Approval of Tentative Budget for Fiscal Year 2016–17

Speakers Tammy Berlin and Chris Harmer addressed the Board on this item.

Dr. Hargens introduced this item and stated that they had embarked on a rigorous budget process in order to support the *Strategic Plan: Vision 2020*. She reiterated her recommendation that a line item is added for up to \$5 million to the budget in order to provide support to teachers and students and the design of a behavior support system.

Chief Business Officer Tom Hudson, Chief Financial Officer Cordelia Hardin, and Director of Financial Planning and Management John Collopy presented the rationale for the tentative budget. Each Board member had an opportunity to ask questions and provide feedback.

Mr. Brady expressed concern with the district's facilities and asked the presenters to explain why the problem wasn't being addressed in the tentative budget. He questioned a possible need for a tax increase.

Ms. Porter requested more information on the unfunded programs listed within the presentation. She also stated that she wants to ensure the allocation of dollars will provide supports and services in schools which will provide for the good of the students.

Ms. Duncan inquired on the long-term plan to sustain funding for Early Childhood Education.
