THANK YOU FOR YOUR BUSINESS. The warranty for International parts and labor is different for every truck and bus and is based on the type of warranty contract you have. If you are unsure of what is covered under your current agreement, please contact your Bluegrass truck or bus representative for help. Any work performed by BGI which is not covered under warranty carries a one year parts and labor warranty on International parts. Any repair performed on brands other than International carry a variable warranty on labor and parts depending on the vendor. All repairs, not covered under warranty, must be paid in full by either Cash, Fleet Charge PO, Company PO or Net Terms at or before the time of pickup. Any repair costs mistakenly identified as a warranty repair but later determined to be out of warranty are the responsibility of the customer. A \$50 per day storage fee may be assessed for any vehicle which remains on the Bluegrass International premises beyond 7 days after completion of work.

Estimate Disclaimer :

The costs reflected in this estimate are based on an initial diagnostics of your vehicle and may change based on additional repairs needed or changes to parts costs that are out of Bluegrass International's control.
