Recommendation/Motion: Approve the meal price increase for School Year 2016-17.

Background/Rationale: School Program regulations at 7 CFR 210.14(e) require school food authorities (SFAs) participating in the National School Lunch Program to ensure sufficient funds are provided to the nonprofit school food service account for meals served to students not eligible for free or reduced price meals. There are two ways to meet this requirement: either through the prices charged for “paid” meals or through other non-Federal sources (the District Funds) provided to the nonprofit school food service account.

The SY 2016-17 Paid Lunch Equity (PLE) tool provided by USDA was utilized to ensure that the FCPS Nutrition Program will be in compliance with the USDA requirements for the SY 2016-17.

Approval of the proposed meal increase will allow the FCPS Child Nutrition Program to be in compliance with 7 CFR 210.14(e) for SY 2016-17.
